NEW JERSEY SCHOOLS DEVELOPMENT AUTHORITY BOARD OF DIRECTORS MEETING

WEDNESDAY, AUGUST 6, 2014

A meeting of the Board of Directors of the New Jersey Schools Development Authority ("SDA" or "the Authority) was held on Wednesday, August 6, 2014 at 9:00 AM at the offices of the Authority at 32 East Front Street, Trenton, New Jersey.

Participating were:

being a quorum of the Board. Mr. Egan, Mr. Moore, Mr. Lewis-Powder and Mr. Piaia participated in the meeting by telephone conference.

At the Chairman's request, Charles McKenna, chief executive officer; Jason Ballard, chief of staff; Andrew Yosha, executive vice president; Jane Kelly, vice president & assistant secretary (by telephone conference); Donald Guarriello, vice president and chief financial officer; Raymond Arcario, vice president; Albert Barnes, chief counsel; Corrado Minervini, program director; Susan Pacuta, director; Sean Murphy, director; Ritchard Sherman, managing

director; and Gregory Voronov, managing director, of the SDA participated in the meeting. Amy Herbold of the Governor's Authorities Unit also participated in the meeting.

The meeting was called to order by the Chairman of the Board, Mr. Walsh, who requested that Ms. Kelly read the requisite notice of the meeting. Ms. Kelly announced that the meeting notice had been sent to the *Trenton Times* and *Star-Ledger* at least 48 hours prior to the meeting, and had been duly posted on the Secretary of State's bulletin board at the State House in Trenton, New Jersey.

Approval of Meeting Minutes

Mr. Walsh presented for consideration and approval the Minutes of the July 2, 2014 Open and Executive Session meetings. A copy of the minutes and a resolution had been provided to the Members for review in advance of the meeting. Upon motion duly made by Mr. Luckie, and seconded by Ms. Hassett, the Open and Executive Session minutes of the July 2, 2014 meeting were approved by the Board upon its unanimous vote in favor of the resolution attached hereto as *Exhibit 3a./3b*.

Authority Matters CEO Report

The Chairman asked Mr. McKenna to provide the Members with the CEO Report. Mr. McKenna said that work on the TCHS Swing Space is more than 95% complete across all of the buildings. He advised the Board that the site investigation and environmental review of the existing building by the SDA's Design Consultant has been completed, with a Draft Preliminary Report currently under SDA review. He said that the structural investigation by the Design Consultant is ongoing, with a Preliminary report expected in 2 to 4 weeks. He said that it appears as though the building was constructed differently than its design documents with the

result that it is necessary to conduct a review to ensure that retaining the clock tower will not compromise the building's structural integrity. Mr. McKenna said that there will be significant discussion with the community regarding the matter. He said that he does not believe that this will impact the project schedule. He emphasized that efforts will be made to retain the clock tower, however, there will be a cost element to consider. He said great efforts have been made to communicate with the community and those efforts will continue. He noted that SDA programming meetings with the District are continuing.

Next, Mr. McKenna discussed the status of the Elizabeth Academic HS project. He said that work is progressing well on the Academic Project, adding that footings and foundation work and structural steel erection activities have been completed. He said that work is progressing well on the electrical duct-bank for the new structure and that the mechanical, electrical and plumbing trades are currently working to rough-in the new structure while masonry activities continue on the interior as well as the building envelope.

With respect to the Phillipsburg High School project, Mr. McKenna advised the Board that construction work activities continue to progress well. He noted that excavation, footing and foundation work are underway, and complete in certain areas. In continuing, Mr. McKenna reported that structural steel erection is projected to commence in late August/early September and that exterior color samples of blended brick, cast stone and aluminum windows were reviewed and approved by the District on July 7.

Mr. McKenna reported that site work, storm water system and structural fill of the Paterson Marshall Street project site is complete. He said that masonry southwest and north elevations of basement footings and foundations have been formed, poured and completed. He noted that structural steel commencement is still projected for late August/early September.

With respect to the Jersey City PS No. 20 project, Mr. McKenna reported that the contractor has mobilized on-site and work is progressing well. He said that the site work is ongoing with approximately 80% of footings and foundations work completed. He advised the Board that steel erection, at 40% complete, is also progressing well. Mr. McKenna said that, as discussed at the SRC meeting, during footings and foundations excavation, the GC encountered unsuitable soil (non-compactable, not contaminated) through the building footprint. He explained that the contract provided a \$500,000 allowance specifically to address unsuitable soils and that SDA authorized use of that allowance amount, monitored on a time and materials basis. He said that, in order to properly address found unsuitable soils beyond the allowance value, he issued two Change Orders-one in the amount of \$488,887.94 and one in the amount of \$300,000. He said that this issue arose the day before the July School Review Committee (SRC) meeting, so he discussed it with the Committee. Mr. McKenna explained that most of this Change Order work has been completed as it was necessary to avoid halting the work and to maintain the project schedule as well as the integrity of the site. Mr. McKenna said that Management is seeking Board ratification of its issuance of the Change Orders. Mr. Walsh questioned the basis for the original contract allowance. Mr. Minervini explained the basis for the \$500,000 allowance which was based upon information provided by the consultant and was later determined to be based on incorrect assumptions. He also discussed the process followed by staff when the current issue arose and explained how initial allowance amounts are generally calculated.

A resolution pertaining to the Change Orders and ratification of Management's actions in connection therewith had been provided to the Members in advance of the meeting. Upon a motion by Mr. Vargas, and seconded by Mr. McNamara, the Board ratified Management's issuance of the Change Orders by its unanimous vote in favor of the resolution attached hereto as **Exhibit 4ai.**

Next, Mr. McKenna reported that the demolition/abatement contractor has mobilized onsite for the Garfield James Madison Elementary School No. 10 project and that work is progressing well. He said that, once abatement is complete, physical demolition of the existing James Madison School (Phase I), will begin. He said that construction documents for (Phase II), the new James Madison School, are currently under review at the DCA.

In continuing, Mr. McKenna reported that the Contractor has installed sediment and erosion control devices, begun removing topsoil from the construction areas and begun excavation for the storm water detention system at the Bridgeton Quarter Mile Lane Elementary School project.

Mr. McKenna reported that ongoing work at the Newark Elliott Street Elementary School project includes placement of perimeter footings which are nearly complete. He said that also ongoing are structural steel erection which is nearing completion and utilities for the cafeteria, concrete, masonry and removal of excess fill from the site.

With respect to the Keansburg Joseph C. Caruso Elementary School project, Mr. McKenna reported that this design-build project is in final design, with construction start anticipated for early August 2014. He said that design packages for footings and foundations, under-slab utilities and structural steel have been completed and submitted to DCA for code review.

Mr. McKenna reported that the Long Branch Catrambone Elementary School project is in final stages of construction. He said that the DCA is in the process of conducting inspections with final approval expected in August. He added that DCA has issued final approvals for the 3

elevator, wheelchair lift, plumbing, HVAC and fire protection. He said that project completion is anticipated for November 1, 2014 which is ten months ahead of schedule. He said that furniture is being delivered and installed and that commissioning is in progress and will be complete before September 1. Mr. McKenna reported that tours have been conducted of the Catrambone School and that both Mr. Vargas and Mr. Capelli have participated. Mr. Vargas and Mr. McKenna both commented on how impressive the school is as well as the excellent job being done by SDA staff member Cheryl Walcott Bediako and her staff with respect to the facility's furniture. Mr. McKenna said that there will be a ribbon cutting ceremony in which Governor Christie will participate. He said that this will be the first time that the same Governor attended both the groundbreaking and the ribbon cutting ceremony for a school.

Next, Mr. McKenna advised the Board that the New Brunswick Redshaw Elementary School project is approaching the final stages of construction. He said that painting is complete, ceiling tiles are installed throughout (with the exception of the Multi-Purpose room which is nearing completion). He reported that flooring is complete--other than the specialty flooring for the gymnasium--and that millwork has been delivered and installed. Mr. McKenna said that final installation and testing is in progress for electrical, HVAC, plumbing and fire protection systems. He said that project completion is anticipated for November 1, 2014 which is ten (10) months ahead of schedule.

Mr. McKenna reported that the Newark Oliver Street Elementary School project is in final design. He said that the design builder is continuing installation of foundations with steel erection planned to begin the second week of August.

In continuing, Mr. McKenna advised the Board that early site package work continues on the Newark South Street project with expected completion in December 2014. He said an Next, Mr. McKenna provided an update on SDA procurement activity. He said that the procurement for Design-Build Services for the Elizabeth New Elementary School project was advertised on June 9, with technical and price proposals due on September 18. He said that the procurement for Internal Auditing Services for design-build projects was considered by the Audit Committee in July and an award recommendation will be presented for approval later in the meeting.

Mr. McKenna advised the Board that the procurement for the Site Consultant Services Task Order Contract was advertised on May 28. He said that technical and price proposals were received from 24 firms on June 24. He advised that the procurement process is ongoing and an award recommendation will be presented for approval at the September board meeting.

In continuing, Mr. McKenna reported that the procurement for Independent Auditor Services was advertised on June 14. He said that technical and price proposals were received from 4 firms on July 8. He advised that the procurement process is ongoing and an award recommendation will be presented for approval at the September board meeting.

Next, Mr. McKenna reported that the procurement for a Broker for the Business and Real Estate Property and Casualty Insurance Program was advertised on June 5. He said that technical proposals were received from 3 firms on July 10, adding that the procurement process is ongoing and an award recommendation will be presented for approval at the November board meeting.

Finally, Mr. McKenna reported that, on July 18, SDA issued a notice of award to Terminal Construction Corporation for the Design-Build Contract for the new Gloucester City ES/MS. He reminded the Members that this award was approved by the Board at the July Board meeting. He said that a bid protest was filed and denied by the Authority, and that no appeal of the denial was filed.

With respect to meetings, events and outreach, Mr. McKenna advised the Board that a "topping off" beam signing was held at the Elizabeth Academic Magnet High School on July 10. He said that the final beam, painted white, was raised into place. He noted that legislators and district officials attended the event.

Mr. McKenna also reported that he met with the members of the Healthy Schools Now Coalition for an informal discussion on July 16 in the Paterson district. He said that participants had an interesting exchange of ideas focused on how to improve communications. He said that staff will be exploring certain ideas raised and continuing to dialogue with the Coalition.

In continuing, Mr. McKenna advised the Board that SDA staff participated in an event held by the African American Chamber of Commerce (AACC), in conjunction with the State Division of Property Management & Construction, on how to do business with the SDA. Mr. McKenna said that the AACC is energized by the TCHS project and the hope that local contractors might be in a position to work on the job. He said that, while the SDA cannot tell a contractor which subcontractors to utilize, staff will provide a list of potential subcontractors to the general contractor. He said that the event was held on July 25 at the auditorium at Trenton School District offices.

Mr. McKenna noted that SDA staff will be participating in a groundbreaking event for the Bridgeton projects the following day, August 7 at 10 a.m. and extended an invitation to interested Members. Finally, Mr. McKenna advised the Members that SDA released its Summer Newsletter on July 30. He said that the Newsletter was distributed to SDA's stakeholders including SDA Board Members, school districts, contractors, legislators, community groups and others. He commended Ms. MacLean and the Communications staff for their good work.

Audit Committee Report

The Chairman then requested that Mr. Nixon provide the report of the Audit Committee. The Chairman noted that he, along with Messrs. Capelli and Egan are recused from participating in agenda item 5a., which Mr. Nixon will be discussing later in his report. Mr. Nixon then reported that the Audit Committee met on July 21, 2014. He said that Management had provided the Committee with the June 2014 New Funding Allocation and Capital Plan Update. He advised the Board that there were no changes reported in the Unforeseen Events Reserve and 2008 Capital Plan Emergent Project Reserve balances during the reporting period. He further advised that there was a \$3.5 million increase in the Planning Reserve and a \$14.6 million decrease in the 2011 Capital Plan Emergent Projects Reserve Balance.

Mr. Nixon reported that the reserve balance for the Regular Operating Districts ("RODs") increased by \$2 million during the reporting period due to a reduction in state share for grant projects nearing completion.

In continuing, Mr. Nixon reported that Management shared with the Committee the results of a recent statutorily required audit focusing on the processes and procedures followed on construction of an elementary school project. He advised that the audit determined that state funds were expended in accordance with the grant agreement, applicable laws and regulations. He said that one low risk observation, pertaining to construction change orders, is being looked into by staff for potential cost recovery.

Next, Mr. Nixon reported that the Committee was provided with the June 2014 Monthly Financial Report. He said that, year-to-date, the Authority's operating expenditures total \$9.6 million which is \$1.8 million lower than the operating budget for the corresponding period. He said that this is a \$376,000 decrease from actual expenses for the corresponding period in the prior year, noting that the decrease is largely due to lower monthly rent expenses. He reported that, as of June 2014, year-to-date project expenditures are \$120.5 million, an increase of \$25.2 million as compared to prior year actual expenditures. He said that this is largely attributable to increased spending for construction related activity of \$26.4 million and other project related activity along with an insurance claim cost recovery offset by a decrease in grant activity.

Mr. Nixon then noted that, since inception, 68% of the funds authorized for the SDA Districts have been disbursed. He reported that 96% of all SDA disbursements relate to school facilities projects and 4% relate to program administrative and general expenses. Mr. Nixon reported that the estimated value of current school facilities project activity is approximately \$2.2 billion. Mr. Nixon advised the Board that the budget re-forecast process is underway and the results will be presented to the Members in the Fall.

Mr. Nixon then advised that Management presented and the Audit Committee is recommending approval of a contract amendment for Experis Finance US, LLC (Experis) consultant services. Referencing materials that had been previously provided for the Members' review, he noted that Experis currently provides auditing consultant services for the Authority. He explained that the amendment for \$20,000 is for additional hours that are needed for Experis to complete an ongoing audit and to provide general assistance to other SDA auditors on the first phases of additional audits. Ms. Pacuta clarified statutory requirements as they pertain to audits of the SDA demonstration projects. He described Experis' work in connection therewith. Mr. Nixon asked for a vote on the recommended Contract Amendment.

A resolution pertaining to the Contract Amendment for Experis Finance US, LLC had been provided to the Members in advance of the meeting. Following discussion, upon a motion by Mr. Vargas and seconded by Ms. Hassett and with Messrs. Walsh and Egan recused from the matter and abstaining, the Contract Amendment for Experis Finance US, LLC in the amount of \$20,000 was approved by the Board upon its vote in favor of the resolution attached hereto as **Exhibit 5a.**

Lastly, Mr. Nixon advised that Management presented and the Audit Committee is recommending approval of contract awards for internal auditing consultant services. Referencing materials that had been previously provided for the Members' review, Mr. Nixon and Mr. Murphy explained the Request for Proposals (RFPs) process along with the terms of the recommended awards. Ms. Pacuta provided additional details relative to the work, applicable rates and the process followed. After discussion, Mr. Walsh asked for a vote on the awards.

A resolution pertaining to the Internal Auditing Consultant Services Award had been provided to the Members in advance of the meeting. Upon a motion by Mr.Vargas and seconded by Mr. Walsh the award of contracts for Internal Auditing Consultant Services to Experis Finance (\$128,000), Smolin, Lupin & Co., P.A. (\$65,000) and Smolin, Lupin & Co., P.A. (\$105,000) for packages 1 through 3 respectively was approved by the Board upon its vote in favor of the resolution attached hereto as **Exhibit 5b**.

School Review Committee Report

Preliminary Project Charter – Perth Amboy School District – Seaman Avenue Elementary School; 2) Preliminary Project Charter – Vineland School District – New Middle School; 3) Release of Funds from Program Reserve – Hoboken School District – Hoboken Brandt School - Emergent Project – Exterior Masonry; 4) Release of Funds from Program Reserve – Jersey City School District – Alexander D. Sullivan School #30 - Emergent Project – Exterior Masonry; 5) Release of Funds from Program Reserve – Jersey City School District – Nicolaus Copernicus School #25 - Emergent Project – Roof and Window Replacement; 6) Release of Funds from Program Reserve – Jersey City School District – A. Harry Moore School - Emergent Project – Exterior Masonry

The Chairman then requested that Mr. Luckie provide the report of the School Review Committee. He reported that the Members are being asked to approve a Preliminary Project Charter for the Seaman Avenue Elementary School in the Perth Amboy School District. He said that the 2012 Capital Plan identified a high priority educational need at all grade levels in Perth Amboy that resulted in discussions with the school district. Mr. Luckie said that, following approval of the Capital Plan, the SDA commenced review and validation activities and a working group consisting of the district, DOE and SDA sought to identify existing and proposed school facilities to meet the district's needs. He explained that the working group identified the need for a new elementary school which Management is recommending to be delivered on the district's Seaman Avenue site through the kit of parts and Design-Build project delivery approach. Mr. Luckie noted that, upon completion, the new school will be an approximately 120,000 SF facility to educate 700 students in grades K through 5. Mr. Luckie noted that the project budget is in the amount of \$56,760,222. Mr. Sherman and Mr. Voronov provided additional details regarding the project and project costs.

A resolution pertaining to the Preliminary Project Charter for the Seaman Avenue Elementary School had been provided to the Members in advance of the meeting. Following Next, Mr. Luckie reported that the Members are being asked to approve a Preliminary Project Charter for a New Middle School in the Vineland School District. He explained that, in 2013, the DOE identified overcrowding in the Vineland Public School District. He said that, in January 2014, the SDA Board approved an amendment to the Capital Plan portfolio identifying the Vineland New Middle School project for validation and advancement. He noted that a working group comprised of the SDA, DOE and district convened and has confirmed that advancement of the project would fully address district-wide overcrowding and educational needs for all students in grades Pre-K through 8. He said that, upon completion, the project will be an approximately 105,000 square foot facility to educate approximately 620 students in grades 6 to 8 on the SDA-owned Lincoln Avenue site in the Vineland School District. Mr. Sherman and Mr. Voronov provided additional details regarding the project.

A resolution pertaining to the Preliminary Project Charter for the New Middle School in the Vineland School District had been provided to the Members in advance of the meeting. Upon a motion by Mr. Vargas, and seconded by Mr. Walsh, the resolution attached hereto as *Exhibit 6b.* was unanimously approved by the Board.

Next, Mr. Luckie discussed Management's request that the Board approve the Release of Funds from the Program Reserve for an exterior masonry emergent project at the Alexander D. Sullivan School #30 (Sullivan School) in the Jersey City School District. He reported that the Sullivan School is an approximately 71,000 square foot facility educating approximately 803 students in grades Pre-K to 5. Mr. Luckie said that, following joint site visits conducted by SDA and DOE staff to review potential emergent conditions in the Jersey City School District, the

DOE issued pre-construction approval in July 2012 for an emergent project to address conditions related to the building's exterior masonry. He said that, after receipt of pre-construction approval, the SDA issued a grant offer to the District which will advance pursuant to SDA delegation for district management. Mr. Luckie said that the funding requested to address the emergent project at the Sullivan School is \$1,094,000. Mr. Voronov then responded to questions posed by the Members.

A resolution pertaining to the Release of Funds from the Program Reserve for the Alexander D. Sullivan School #30 had been provided to the Members in advance of the meeting. Following discussion, upon a motion by Mr. Maloney, and seconded by Mr. Vargas, the resolution attached hereto as *Exhibit 6d*. was unanimously approved by the Board.

Next, Mr. Luckie discussed Management's request for approval of a Release of Funds from the Program Reserve to address the emergent project for the Brandt School in the Hoboken School District for exterior masonry repair. He reported that the Brandt School is an approximately 83,000 square foot facility educating approximately 500 students in grades Pre-K to K. Mr. Luckie said that, following joint site visits conducted by SDA and DOE staff to review potential emergent conditions in the district, the DOE issued pre-construction approval in July 2012 for an emergent project to address conditions related to the building's exterior masonry. Mr. Luckie informed the Members that, after receipt of pre-construction approval, the SDA issued a grant offer to the district which will advance pursuant to SDA delegation for district management. He noted that the funding requested to address the emergent project at the Brandt School is in the amount of \$920,000.

A resolution pertaining to the Release of Funds from the Program Reserve for the Hoboken Brandt School had been provided to the Members in advance of the meeting. Following discussion, upon a motion by Mr. Vargas, and seconded by Mr. Maloney, the resolution attached hereto as *Exhibit 6c.* was unanimously approved by the Board.

In continuing, Mr. Luckie reported that the Members are being asked to approve the Release of Funds from the Program Reserve for the Nicolaus Copernicus School #25 (Copernicus School) in the Jersey City School District for an emergent project for roof and window replacement. He informed the Members that the Copernicus School is an approximately 113,000 square foot facility educating approximately 848 students in grades Pre-K to 5. Mr. Luckie said that, following joint site visits conducted by SDA and DOE staff to review potential emergent conditions in the district, the DOE issued pre-construction approval in July 2012 for an emergent project to address conditions related to the building's roof and windows. He noted that, after receipt of pre-construction approval, the SDA issued a grant offer to the district which will advance pursuant to SDA delegation for district management. Mr. Luckie said that the funding requested to address the emergent project at the Copernicus School is \$2,703,000. Mr. Voronov provided additional details regarding the project.

A resolution pertaining to the Release of Funds from the Program Reserve for the Nicolaus Copernicus School #25 had been provided to the Members in advance of the meeting. Following discussion, upon a motion by Mr. Vargas, and seconded by Mr. Nixon, the resolution attached hereto as *Exhibit 6e*. was unanimously approved by the Board.

Lastly, Mr. Luckie reported that Members are being asked to approve the Release of Funds from the Program Reserve for the A. Harry Moore School (Moore School) in the Jersey City School District. He informed the Members that the Moore School is an approximately 62,000 square foot facility that houses a specialized program to educate approximately 200 students. He explained that, following joint site visits conducted by SDA and DOE staff to review potential emergent conditions in the district, the DOE issued pre-construction approval in July 2012 for an emergent project to address conditions related to the building's exterior masonry. He added that, after receipt of pre-construction approval, the SDA issued a grant offer to the district which will advance pursuant to SDA delegation for district management. Mr. Luckie said that the funding requested to address the emergent project at the Moore School is \$2,353,000.

A resolution pertaining to the Release of Funds from the Program Reserve for the A. Harry Moore School had been provided to the Members in advance of the meeting. Following discussion, upon a motion by Mr. Vargas, and seconded by Ms. Hassett, the resolution attached hereto as *Exhibit 6f*. was unanimously approved by the Board.

Reports/Other

The Chairman asked Mr. Ballard for an update regarding Project Closeouts. Mr. Ballard informed the Members that there was nothing current to report regarding project closeouts. He then thanked the Communications staff for their assistance in connection with the African American Chamber of Commerce event. Mr. McKenna also thanked Ms. Simmonds for her presentation, noting that she did an excellent job.

Public Comments

The Chairman then opened the Public Comments portion of the meeting. He invited Ms. Mo Kinberg of the Healthy Schools Now Coalition/NJ Work Environment Council to address the Members. Ms. Kinberg thanked Mr. McKenna for participating in a meeting with a community group in Paterson and said that she is hopeful that such meetings will continue. She then provided a brief overview of the meeting discussion and said that information provided regarding projects that had been delegated to the district was extremely helpful. At Ms. Kinberg's request, Mr. McKenna then provided an update regarding the Jersey City No. 20 project. He clarified that the soil issues that exist on the project pertain to compactability and not contamination.

Ms. Kelly then advised the Members and the Public that the Board will be adjourning into Executive Session to discuss one matter that had been considered by the SDA Real Estate Committee, a Lease Renewal for space at Nos. 30 and 40 Van Dyke Avenue in New Brunswick, New Jersey.

Mr. Walsh then asked for a motion to adjourn the meeting into Executive Session. Upon motion and with unanimous consent, the meeting adjourned into Executive Session.

Following discussion in Executive Session, the Board returned to Open Session.

A resolution for approval of the Lease Renewal for Nos. 30 and 40 Van Dyke Avenue in New Brunswick, New Jersey had been provided to the Members in advance of the meeting. Upon a motion by Mr. Luckie, and seconded by Mr. Vargas, and with Mr. Egan recused from the matter and having left the meeting, the resolution attached hereto as *Exhibit A1*. was unanimously approved by the Board.

Mr. Walsh then asked for a motion to adjourn the meeting. Upon motion and with unanimous consent, the meeting adjourned.

We are seeking the Board's approval to award a contract for Independent Auditor Services. The term of the agreement will be for an initial three years.

BACKGROUND

Pursuant to Governor James E. McGreevey's Executive Order No. 122 ("EO 122"), effective on July 23, 2004, the Board of Directors ("Board") of the New Jersey Schools Development Authority ("Authority" or "NJSDA"), by and through the Board's Audit Committee ("Audit Committee"), seeks to engage a qualified Public Accounting firm (a "Consultant") to provide independent auditor services. The firm selected as the Consultant shall be required to perform annual financial statement audits in compliance with generally accepted government auditing standards and all other applicable professional auditing standards. These services shall be required for the Authority's financial statements for the fiscal years ending December 31, 2014, 2015 and 2016. The contract may be extended for two one-year terms covering the fiscal years ending December 31, 2017 and 2018, if permissible by State law and/or the Governor's Office at such time, and approved by the Board of Directors. As provided in EO 122, the Consultant shall be responsible for: publicly attesting to the fairness of the Authority's financial statements; considering the effectiveness of internal controls as a basis for designing audit procedures; and through the issuance of management letters, making comments and recommendations which, when implemented, would improve the design or operation of internal control systems.

DESCRIPTION

The consultant's services will primarily include: (1) annual audits of the Authority's financial statements in compliance with generally accepted government auditing standards and all other applicable professional auditing standards; and (2) the preparation of annual management letters for the purpose of discussing internal control concerns identified during the audits, accompanied by recommendations to address those concerns. Additionally, among other things, the Consultant shall meet privately with the Audit Committee at least twice year, at times to be determined by the Audit Committee, provided that one of the meetings shall be held prior to commencement of the audit, and the other shall be held upon issuance of the final audit report. The scope of services does not include an audit of the Authority's internal control over financial reporting and, accordingly, the Consultant will not express an opinion on the effectiveness of the Authority's internal control. PROCUREMENT PROCESS

This package was advertised as a "Price and Other Factors" solicitation beginning on June 4, 2014 on the NJSDA website and on the State of New Jersey Business Opportunities website. For this procurement, price was weighted as 20% of the overall weight, and all non-price factors had a combined weight of 80%.

An Evaluation Committee consisting of three Audit Committee members was established.

Firms interested in submitting a proposal were required to send an e-mail giving Notice of Intent to Participate (NOI) by June 16, 2014. NOIs were received from six firms. On June 20, 2014, NJSDA issued an addendum which included answers to questions posed by potential firms and a list of firms that intended to participate in this procurement. Responsive proposals were received from four firms by July 8, 2014. Technical Proposals were evaluated by the Evaluation Committee. Evaluations were based upon the information provided by the firms in response to the RFP for this project. The three Committee members independently evaluated the Technical Proposals for Independent Auditing Services based on the following criteria:

- The Bidder's Demonstrated Ability and Qualifications to Conduct Governmental Financial Statement Audits, as Evidenced in Resumes and Case Studies;
- The Bidder's Documented Experience in Successfully Completing Governmental Financial Statement Audits of a Similar Size and Scope to the Work Required by the RFP, as Evidenced in Case Studies;
- The Bidder's Detailed Approach and Plans to Perform the Services Required by the Scope of Services of the RFP;
- The Bidder's Familiarity with Federal and State Laws, Rules and Regulations Relevant to Governmental Financial Statement Audits, as Evidenced in Case Studies; and
- The Bidder's Quality of Response to the RFP Package.

Each Evaluation Committee member evaluated each Technical Proposal, assigning a raw score for each criterion on a scale of 0 to 10 as follows:

- Outstanding (9–10): depth and quality of response offers significant advantages.
- Superior (7-8): exceeds RFP requirements with no deficiencies.
- Sufficient (5-6): meets RFP requirements with no significant deficiencies.
- Minimal (3-4): meets RFP requirements but contains some significant deficiencies.
- Marginal (1-2): comprehends intent of RFP but contains many significant deficiencies.
- Unsatisfactory (0): requirements not addressed and lack of detail precludes adequate evaluation.

Weighting factors were applied to each of the Evaluation Committee member's raw scores for each criterion to arrive at a total weighted score as follows:

For each firm's Technical Proposal, the individual criteria scores awarded by a particular Evaluation Committee member were added together to calculate a Non-Price Score for that firm. The maximum Non-Price Score is 100. All of the scores awarded by the Evaluation Committee members to a particular firm's Technical Proposal were added together and averaged to arrive at a Non-Price Score for each firm. The responsive firms, their scores and ranks are listed in Table 1 below:

The results of the Evaluation Committee's review of the Technical Proposals were reported to the Audit Committee by the Chairman of the Audit Committee on July 29, 2014. Pursuant to EO 122, upon receipt of the Evaluation Committee's report, the Audit Committee shall review the report and determine whether it is necessary for the Audit Committee to interview the responsive firms in order to finalize the Non-Price scoring. If it is determined that interviews are to be conducted, the Audit Committee will re-rank the firms based upon the interviews. In this instance, the Audit Committee determined interviews were not necessary and therefore the Non-Price Scores based solely on the Evaluation Committee's review of the Technical Proposals became the Final Non-Price Scores.

Once the Final Non-Price Scores for all firms were determined, the Authority tabulated the Price Scores. The Fee Proposal requested lump sum fees applicable to Fiscal Years 1, 2 and 3, as well as for Optional

Years 4 and 5^1 . The lowest responsive Fee Proposal was awarded the maximum number of points for the price component, which is 100. All other Fee Proposals were awarded points based on the percentage that each proposal exceeded the lowest Fee Proposal. After the Price Scores were determined for all responsive firms, the Price Scores were adjusted by a weighting factor of 20%. The Non-Price Scores for "Other Factors" criteria were adjusted by a weighting factor of 80%. The Price Score and Non-Price Score for each responsive firm were added together for a Final Combined Score. The maximum Final Combined Score is 100. The Final Combined Scores and Final Rankings are listed in Table 3 below:

Since the hourly rates were not an element of the formula used to tabulate the Price Scores, they were subject to negotiation. At the direction of the Chairman of the Audit Committee, NJSDA staff initiated negotiations with the top ranked firm, Ernst & Young, on July 31, 2014. Successful negotiations resulted in the reduced loaded hourly rates for the top ranked firm for the term of the agreement as listed in Table 5 below:

INTRODUCTION

I am writing to recommend approval by the Members of the Authority of Amendment No. 3 in the credit amount of \$1,373,884.39 for unused professional services from Michael Graves & Associates (MGA) under Contract No. PA-0024-A01 associated with the New P.S. No. 16 Elementary School Project (Project). A credit amendment is the accounting mechanism by which the New Jersey Schools Development Authority (NJSDA) de-obligates a contract's unused funds. The value of this credit amendment represents a 61.9% reduction to the total contract value. Execution of Amendment No. 3 is necessary to advance the contract close-out. Pursuant to the NJSDA Operating Authority adopted by the Board on December 1, 2010, as amended March 7, 2012, a credit amendment which singularly exceeds \$100,000 or 10% of the contract value requires approval by the Members of the Authority. This credit amendment exceeds \$100,000 and 10% of the contract value.

PROJECT BACKGROUND

The Project is proceeding pursuant to Design-Build delivery. A contract for Design-Build services was awarded to Hall Construction Co., Inc., with the DIGroupArchitecture and Planning, LLC as the design consultant team lead. The new school is designed to be a 109,513 square foot facility to educate 705 students from Pre-Kindergarten through 8th grade.

The project history includes a contract with MGA executed in August, 2004 to provide design and construction administration services, work which had been suspended on several occasions.

After the project was identified for advancement as part of the SDA 2011 Capital Plan, a review of the MGA design determined that it was not sufficiently supportive of the goals of standardization and that the project would advance using the SDA Kit of Parts approach and Design-Build methodology.

REASON FOR CHANGE

Amendment No. 3 is to credit the remaining unused balance of funds on MGA's contract, totaling \$1,373,884.39, as MGA's services are no longer needed. Funding de-obligation is required prior to the close out of the Contract.

INTRODUCTION

We are writing to recommend approval by the Members of an amendment to the NJSDA's Capital Plan which shall serve to incorporate the Passaic City New Leonard Place Elementary School project for advancement. We are also writing to recommend approval by the Members of the Preliminary Project Charter for the Passaic City New Leonard Place Elementary School project.

The Operating Authority adopted by the Board on December 1, 2010 as amended on March 7, 2012, requires approval by the Board of the Authority's Capital Plans. The Operating Authority also requires approval by the Board of Project Charters.

BACKGROUND

District Capacity Needs

The Passaic City School District lacks capacity for over 3,500 students in grades Pre-K to 8.

At the March 7, 2012 SDA Board Meeting, the Members approved the Authority's 2012 Capital Plan. Among the included projects and needs, that Plan identified the Passaic City Dayton Avenue Education Campus (Dayton Avenue project) for advancement. In November 2013 the Members approved the Preliminary Project Charter for the project. The project scope for the Dayton Avenue project calls for construction of a new school facility to educate approximately 2,740 students in grades Pre-K to 8. With the capacity generated by that new facility, there will nonetheless remain a capacity need in the district for an additional 770 students in grades Pre-K to 8.

Project Logistics

Planning discussions to address the scope of the Dayton Avenue project had originally anticipated the need for removal of existing and occupied temporary classroom units (TCUs) from the site after construction of the new Dayton Avenue facility. However, development and evaluation of conceptual design alternatives for the project now recognize that the most effective and efficient utilization of the Dayton Avenue site requires removal of the TCUs prior to construction of the new facility.

As a result, the District and SDA reviewed potential alternatives to provide for the students currently being educated in the TCUs, thereby allowing for relocation or removal of the TCUs from the site in advance of construction of the new facility. Options considered included the relocation of the TCUs to other areas of the Dayton Avenue site, to other District sites, and/or to the SDA acquired Leonard Place site. Consideration was also given to the potential to construct a new elementary school at the Leonard Place site which would allow for the temporary relocation of students currently educated in the Dayton Avenue TCUs to other facilities within the District until completion of the Dayton Avenue Educational Campus, while simultaneously providing additional and much-needed capacity.

The review of the options considered both potential cost and schedule impacts for each option as well as review of the long term needs of the District. Discussions with the District recognized that advancement of a new elementary school project on the Leonard Place site would serve to further address the severe overcrowding which the District continues to experience. It was also recognized that there is significant cost associated with temporary relocation of the TCUs to any location and that temporary relocation to the Leonard Place site would likely create a logistics concern for future development of that site.

Based on these considerations, as well as anticipated budget and schedule impact, the District/SDA Working Group is recommending advancement of a New Leonard Place Elementary School project as further described below. Coordinating the logistics and delivery of the two projects will result in the overall benefit of providing the District with additional capacity for 3,368 students, an improved approach that more fully addresses District needs.

NEW LEONARD PLACE ELEMENTARY SCHOOL

Prior Project Activity

A project to construct an early childhood center on the Leonard Place site was initially undertaken by the SDA in 2007. Activity included environmental site investigation, site acquisition, relocation and demolition, with expenditures of approximately \$13.1 million for those activities. Project activity was suspended prior to any engagement for design services for the project.

Presently, with the approval by SDA, the Leonard Place site is being utilized by the Design-Builder constructing the New Henry Street Elementary School, which is located across the street from the site, as "lay down" area to facilitate construction of that project. It is anticipated the site will no longer be needed for this purpose by mid-2015.

Current Advancement Status

Analyzing the option to construct a new elementary school on the Leonard Place site, SDA staff undertook a preliminary environmental review of the proposed site. Staff reviewed environmental documents pertaining to the site to identify potential data gaps and identify a preliminary scope of work for closure of these gaps. This review identified scope appropriate for additional investigation through assignment to an engaged Site Environmental Consultant (SEC).

Upon approval of the Preliminary Project Charter, an SEC will be engaged though a task order assignment to complete site investigation activities necessary to support project advancement concurrently with other recommended design activities.

Recommended Project Scope

SDA staff has developed a proposed project scope based on application of standard programmatic models and has considered application of Kit of Parts in project delivery. Based on that analysis, the following project is being recommended for advancement to address District overcrowding.

The recommended project scope calls for the construction of an approximately 100,000 SF new school facility on the SDA owned Leonard Place site. The facility will provide capacity to educate approximately 628 students in grades K to 5.

Project Delivery Recommendation

Alternatives for project delivery, including both Design-Build and Design-Bid-Build have been considered and analyzed by staff. Considerations in this regard have included the size, type, and complexity of the project as well as cost and schedule considerations and availability of SDA resources to support project advancement.

The capacity and grade configuration of the proposed Leonard Place Elementary School align with standard SDA programmatic models and test fits of the existing Leonard Place site have determined that Kit of Parts components may be utilized in the design of the project which will be all new construction. A schedule comparison indicates that a Design-Build approach could deliver the project to the District at least one school year earlier than would a Design-Bid-Build approach. Additionally, an analysis of Design Studio workload and staffing projections has determined that sufficient resources exist to support its advancement through in-house design.

Therefore, it is recommended that this project be advanced utilizing in-house design staff and that bridging documents be prepared to support a Design-Build delivery process. The project budget which has been developed is reflective of the recommendation for Design-Build project delivery.

Project Budget

By providing the New Elementary School at Leonard Place project in conjunction with construction of the Dayton Avenue Project, the District's capacity needs in grades K to 5 will be substantially addressed. The estimated cost of \$56.2 million for the project reflected in the Preliminary Project Charter is inclusive of all prior expenditures of \$13.1 million related to site acquisition, investigation and demolition activities, as well as estimated future costs necessary for advancement of the current project scope. The estimated costs are based upon the application of planning estimates to the current anticipated project scope.

AMENDMENT TO CAPITAL PLAN PORTFOLIO

For the reasons described above, we recommend advancement of a new elementary school at the Leonard Place site sequenced to initiate in advance of construction of the Dayton Avenue project. This option offers the benefit of providing for additional needed elementary school capacity and leverages prior state investment in the acquisition, demolition and site remediation of approximately \$13.1 million for the Leonard Place site. Additionally, upon completion of the new school the TCUs will be able to be removed from the Dayton Avenue site which will facilitate the construction of the Dayton Avenue Project in a more effective and efficient manner.

RECOMMENDATION

The Members of the Authority are requested to approve the amendment to the NJSDA's Capital Plan to incorporate the New Leonard Place Elementary School for advancement and approve the Project Charter for the Passaic City New Leonard Place Elementary School project. In so doing, the Board is providing the Authority with approval to:

- 1. Proceed with in-house design activities.
- 2. Procure necessary professional and construction services in relationship to this project.

The Operating Authority will govern the award of all professional services and construction contracts and the Board's notification of the use of contingency monies.

WHEREAS, the Operating Authority of the New Jersey Schools Development Authority (SDA or Authority) requires that Authority Capital Plans receive approval by the Members of the Authority; and

WHEREAS, the Operating Authority further requires that Project Charters receive the approval of the Members of the Authority; and

WHEREAS, the Passaic City School District lacks capacity for over 3,500 students in grades Pre-K to 8; and

WHEREAS, in March 2012, the Members of the Authority approved the Authority's 2012 Capital Plan which, among its projects and needs, included the Passaic City Dayton Avenue Education Campus (Dayton Avenue project) for advancement; and

WHEREAS, in November 2013, the Members of the Authority approved the Preliminary Project Charter for the Dayton Avenue project; and

WHEREAS, even with the Dayton Avenue project in place there will remain a capacity need in the district for an additional 770 students in grades Pre-K to 8; and

WHEREAS, following discussions with the District, it was determined that advancement of a new elementary school project on the Leonard Place site would serve to further address the severe overcrowding which the District continues to experience; and

WHEREAS, the recommended project scope calls for the construction of an approximately 100,000 SF new school facility to educate approximately 628 students in grades K to 5; and

WHEREAS, project logistics, prior project activity, current advancement status, a recommended project scope, the project delivery recommendation, project budget and the basis of the proposed amendment to the Capital Plan Portfolio are described in detail in the memorandum presented to the Board on this date and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED, that the Members of the Authority hereby authorize and approve the amendment to the SDA's Capital Plan to incorporate the New Leonard Place Elementary School for advancement and approve the Preliminary Project Charter for the Passaic City New Leonard Place Elementary School project.

BE IT FURTHER RESOLVED, that, in so doing, the Members of the Authority authorize management and staff to proceed with in-house design activities and procure necessary professional and construction services in relationship to this project.

BE IT FURTHER RESOLVED, that the SDA Operating Authority shall govern the award of all professional services and construction contracts and the Board's notification of the use of contingency monies.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately, but no action authorized herein shall have force and effect until 10 days, Saturdays, Sundays and public holidays excepted, after a copy of the minutes of the Authority meeting at which this resolution was adopted has been delivered to the Governor for his approval, unless during such 10 day period, the Governor shall approve same, in which case such action shall become effective upon such approval.

INTRODUCTION

The NJSDA previously procured environmental task order services in 2003, 2008 and 2011 to provide for site feasibility investigation and environmental site closure services. Since the current task order contracts will expire in December 2014, the Members of the Authority are requested to approve the award of contracts to twelve firms thereby creating a new pool of firms with relevant experience and qualifications to successfully perform the required site consultant services. Specific work assignments under the contracts will be made by way of "task order" on an as needed basis. The term of agreement for these contracts is three years. For any assignment(s) accepted during the term of the agreement, the firm(s) will be allowed to complete the particular assignment(s), even if extending beyond the term of the agreement. Each of the twelve contracts will individually have a not-to-exceed amount of \$3,000,000.

Task order assignments under this engagement are contemplated to include predesign and site feasibility; environmental site review; early site development; site/civil planning and design; design-build construction administration; emergent projects; and project closeout activities associated with school facilities projects. It is within the NJSDA's discretion to issue any number of task orders to a site consultant during the term of the agreement. Task orders will be awarded pursuant to rotational assignments to pool members for performance of services on a time and materials not-to-exceed basis in accordance with the rates established by the NJSDA (see attached Exhibits A and B), with consideration given to the firms': (1) capacity to undertake the assignment; (2) unique local municipality or school district experience; (3) specialized experience applicable to the assignment; (4) commitment to meet schedule requirements; (5) past performance; (6) assessment of potential conflicts of interest; and (7) number and value of previous awards on the contract in an effort to equitably distribute the work.

PROCUREMENT PROCESS

In accordance with NJSDA regulations, the NJSDA employed a two-step process for this procurement. The first step was to issue a Request for Qualifications and Proposals (RFQ/RFP) and then review all responses in order to shortlist the top twelve ranked firms. The second step was to interview the shortlisted firms with a minimum selection of six firms being recommended for award.

The RFP was advertised beginning on May 28, 2014 on the NJSDA website and the New Jersey State website. In addition, the advertisement was distributed to those firms that were prequalified with a minimum rating of \$5,000,000 in Civil Engineering (P005) or Environmental Engineering (P005) by both the Department of Treasury-Division of Property Management and Construction and the NJSDA.

A Selection Committee consisting of three NJSDA staff members was established.

Firms interested in submitting a proposal were required to send an e-mail giving Notice of Intent to Participate (NOI) by June 9, 2014. NOIs were received from thirty-four (34) eligible firms. Responsive proposals were received from twenty-three (23) firms by June 24, 2014. The Technical Proposals were evaluated by the Selection Committee based on the following criteria:

- Firm's experience in providing the Scope of Services;
- Qualifications and experience of Key Team Members;
- Qualifications and experience of proposed Licensed Site Remediation Professional;
- Firm's qualifications and experience in land development for residential and educational purposes in New Jersey; and
- Firm's approach to managing the contract.

Each Selection Committee member evaluated each Technical Proposal, assigning a raw score for each criterion on a scale of 0 to 10 as follows:

- Outstanding (9–10): depth and quality of response offers significant advantages.
- Superior (7-8): exceeds RFQ/RFP requirements with no deficiencies.
- Sufficient (5-6): meets RFQ/RFP requirements with no significant deficiencies.
- Minimal (3-4): meets RFQ/RFP requirements but contains some significant deficiencies.
- Marginal (1-2): comprehends intent of RFQ/RFP but contains many significant deficiencies.
- Unsatisfactory (0): requirements not addressed and lack of detail precludes adequate evaluation.

Weighting factors were applied to each of the Selection Committee member's raw scores for each criterion to arrive at a total weighted score as follows:

For each firm's Technical Proposal, the individual criteria scores awarded by a particular Selection Committee member were added together to calculate a Technical Proposal Score for that firm. The maximum Technical Proposal Score is 100. All of the scores awarded by the Selection Committee members to a particular firm's Technical Proposal were added together and averaged to arrive at a Technical Proposal Score for each firm. The responsive firms, their scores and ranks are listed in Table 1 below:

A shortlist of the twelve (12) highest-ranked firms was determined based on the Technical Proposal Scores. The shortlisted firms participated in interviews with the Selection Committee on July 30 and 31, 2014. The interviews allowed the firms to expand and detail their firm and team experience with respect to NJSDA requirements for Site Consultant Services. The Selection Committee interviewed each of the shortlisted firms and evaluated each firm on Interview Criteria and Weighting Factors that were the same as those used in the evaluation of the Technical Proposals, as detailed above.

The individual criteria scores awarded by a particular Selection Committee member were added together to calculate an Interview Score for that firm. The maximum Interview Score is 100. All of the Interview Scores awarded to a particular firm by the Selection Committee members were added together and averaged to arrive at an Interview Score for each firm. The shortlisted firms, their scores and ranks are listed in Table 2 below:

Based on NJSDA staff review of the Final Technical Scores and Final Rankings, it was determined to select all twelve shortlisted firms for recommendation of award.

Per the terms of the RFQ/RFP, firms participating in this procurement must be prepared to provide services at standardized hourly rates, as set forth in RFQ/RFP and attached as Exhibit A to this memorandum, when awarded or assigned task orders under this engagement. In addition, the RFQ/RFP stated that the NJSDA would establish standardized fees for field investigation equipment and analytical services following the evaluation of Fee Proposals for same submitted with each firm's Technical Proposal. The Fee Proposals for all shortlisted firms, which had been kept separate and sealed, were opened on August 1, 2014. The fee schedule requested fully loaded billing rates for certain equipment and services. Following a review of the fees submitted by all shortlisted firms, NJSDA staff established uniform rates for the identified equipment and services. Following discussions with each of the selected firms, all twelve firms have agreed to these rates. The negotiated fully loaded billing rates are listed in Exhibit B to this memorandum.

RECOMMENDATION

The Members of the Authority are requested to approve the NJSDA contracting with the twelve firms listed in Table 3 at the rates set forth in Exhibits A and B to this memorandum. Each firm would enter into a contract for a not-to-exceed amount of \$3,000,000 over the three year term of the agreement.

Prior to execution of each contract, the contract and related documentation being reviewed and approved by the NJSDA Division of Chief Counsel.

WHEREAS, SDA executive management has determined it reasonable and appropriate to seek Board approval to award contracts to twelve firms thereby creating a new pool of firms with relevant experience and qualifications to successfully perform the required site consultant services, the terms of which contracts shall be for three years; and

WHEREAS, as proposed, each of the twelve individual contracts will have a not-to-exceed amount of \$3,000,000; and

WHEREAS, the recommendation presented by executive management follows a procurement procedure conducted in accordance with applicable SDA regulations as described in comprehensive detail in the memorandum presented to the Board on this date.

NOW, THEREFORE, BE IT RESOLVED, that the Members of the Authority hereby authorize and approve the award of contracts for site consultant services (GP-0204-L01) consistent with the provisions of the memorandum presented to the Board on this date and the exhibits appended thereto.

BE IT FURTHER RESOLVED, that prior to execution, each contract and related documentation shall be reviewed and approved by the NJSDA Division of Chief Counsel.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately, but no action authorized herein shall have force and effect until 10 days, Saturdays, Sundays and public holidays excepted, after a copy of the minutes of the Authority meeting at which this resolution was adopted has been delivered to the Governor for his approval, unless during such 10 day period, the Governor shall approve same, in which case such action shall become effective upon such approval.

Vendor Services staff continues to participate at mandatory pre-bid and pre-construction meetings to instruct and inform bidders regarding SDA's SBE goals, policies and procedures, including:

- Small Business Enterprise subcontracting goal of 25% of all contracts
- County workforce goals for minorities and females
- Detailed process procedures to monitor and track the progress made toward these goals throughout the life cycle of each project

At these meetings, vendors are strongly encouraged to identify and hire minority-owned and women-owned firms, as well as locally-based enterprises, for diverse business participation on all school building projects. Additional outreach strategies are discussed and utilized.

SMALL BUSINESS ENTERPRISE (SBE) COMPLIANCE MONITORING

The SDA regularly exceeds the State-mandated 25% SBE goal. The total SDA contract dollars awarded from January 1 through June 30, 2014 was \$86,563,799. The figures below demonstrate compliance with this requirement.

SBE Breakdown

The total contract dollars awarded to all SBE contractors was \$63,220,510 (including minorities and women). This represents 73.03% of all SDA contracts.

This report summarizes the Regular Operating District Grant activity from inception to date and for the month of July 2014. Also included is a detailed list of grants executed and grants offered during the reporting period.

Monthly Update:

- 11 grants impacting 6 districts were offered during the reporting period representing \$6.6M in total project costs and state share of \$1.9M.
- 180 grants impacting 50 districts were executed during the reporting period representing \$92.4M in total project costs and state share of \$44.9M.
- 19 grants impacting 10 districts were closed out during the reporting period representing \$48.3M in total project costs and state share of \$17.1M.
- Since inception, over \$2.4B has been disbursed to over 510 regular operating districts through the grant program.
- Since inception over \$3.3B in funding has been approved by the Department of Education and offered to regular operating districts through the grant program.

Christie Administration Joins Bridgeton School District for Groundbreaking Ceremony to Celebrate the Start of Two Addition/Renovation Projects



SDA CEO Charles McKenna joined legislators, local officials and Bridgeton School District officials for a groundbreaking ceremony to celebrate the start of addition/renovation projects at Quarter Mile Lane Elementary School and Buckshutem Elementary School.

The addition and renovation project to the existing Quarter Mile Lane School will increase the capacity of the existing school from 254 students in kindergarten through eighth grade to approximately 730 students in pre-kindergarten through eighth grade. The addition will include a new three-story classroom wing, new gymnasium, multi-purpose room and cafeteria. Renovation work will include conversion of the existing cafeteria to a media center and renovations to existing classrooms.

The addition and renovation project at the existing Buckshutem Road School will increase the capacity of the existing school from 404 students to approximately 580 students in kindergarten through eighth grade. The addition will include new classrooms and a gymnasium. Renovation work will include the conversion of the existing gymnasium to a media center and the existing media center to a student services center.

SDA Highlights Recent Project Activity

During the month of August, SDA issued press releases announcing the start of the design-build contract for the Gloucester City Elementary School/Middle School and the completion of an emergent project at the Orange Preparatory Academy.

SUBJECT: Monthly Financial Report - July 2014

The Office of the Chief Financial Officer is providing the attached monthly financial report to the Members of the Authority for their information. Included on pages 1 and 2 of this report is a "Financial Summary" of the Authority's activities for the year. On pages 3 and 4 of the report is a summary of the Authority's operating expenditures, and headcount information. Page 3A contains an itemized breakdown of personnel costs that have been allocated to school facilities project costs from program general and administrative ("Operating") expense. The basic financial statement and cash flow report follow.

Year-to-Date Authority Operating Expenses (Actual vs. Budget)

For July 2014 year to date, Authority operating expenses, **\$11.1 million**, are **down \$1.8 million** as compared to the operating budget for the *corresponding period*. The deviation of actual expenses versus budget is due to:

- Lower salary & benefit costs **\$1.8 million.** The Authority is currently 18 FTEs under budget. Also, the annual employer pension contribution payment was \$223K lower than anticipated. This variance is offset by the year to date allocation of payroll expense to project cost that is higher than projected, **(\$486K)**.
- Year to date spending reductions related to; MIS projects **\$184K**; Contract Services **\$129K** (including DAG Fees, Internal Audit Fees, and Project Services), and General Office & Facilities **\$115K**.

Year-to-Date Authority Operating Expenses (Actual vs. Prior Year Actual)

For July 2014 year to date, Authority operating expenses, **\$11.1 million**, are **<u>\$1 million</u>** lower as compared to the *corresponding prior year*. The decrease in the year-over-year expense is due to:

- Cost savings related to lower monthly rent expense associated with the lease termination of 1 West State Street office space **\$431K**;
- Lower allocation of salary & benefit costs to project cost in 2014, **\$318K**;
- Lower MIS expenditures for the DOE LRFP project, hardware, and software **\$105K**;
- Lower Internal Audit Fees **\$96K.**

Year-to-Date School Facilities Project Expenditures (Actual vs. Forecast)

For July 2014 year to date, project expenditures, **\$151.5 million**, are **down \$29.3 million** as compared to the capital spending forecast for the *corresponding period*. The variance is primarily due to lower than anticipated expenditures in; grant activity **\$8.1M**, and construction activity **\$21.5M**.

Year-to-Date School Facilities Project Expenditures (Actual vs. Prior Year Actual)

For July 2014 year to date, project expenditures, **\$151.5 million**, have increased by **\$35.3M** as compared to the *corresponding prior year*. The year-over-year variance is attributable to increased spending for construction cost **\$34.2M**, and other project related activity **\$7.7M**, as well as the 2013 insurance claim cost recovery (credit in prior year) for the Elliott Street School **\$8.3M**, offset by a decrease in grant activity, **\$15M**.

Budget Reforecast

The 2014 Budget Reforecast is **\$33.6** million which is **\$2.3 Million** lower than the approved 2014 Annual Budget. The reduced spending projections are primarily attributable to; 18 fewer FTE's resulting in Salary & Benefit cost savings of **\$2.1M**.

Other

Since program inception, 68.8% of the funds authorized for the SDA Districts have been disbursed. Additionally, since program inception 96% of all SDA disbursements relate to school facilities projects and 4% relate to Operating expense.

The estimated value of active school facilities projects is approximately \$2.2B.
