OCTOBER 2, 2019 OPEN SESSION MINUTES

NEW JERSEY SCHOOLS DEVELOPMENT AUTHORITY BOARD OF DIRECTORS MEETING WEDNESDAY, OCTOBER 2, 2019

A meeting of the Board of Directors of the New Jersey Schools Development Authority (SDA or the Authority) was held on Wednesday, October 2, 2019 at 9:00 A.M. at the offices of the Authority at 32 East Front Street, Trenton, New Jersey.

being a quorum of the Board. Mr. Egan, Mr. Elbert, Ms. Lemelle, Mr. Lewis-Powder, Mr. Maloney and Mr. Piaia participated in the meeting by teleconference.

At the Vice Chairman's request, Manuel Da Silva, interim chief executive officer; Andrew Yosha, vice president; Jane F. Kelly, vice president and assistant secretary; Donald Guarriello, vice president and chief financial officer; and Albert Barnes, chief counsel of the SDA, participated in the meeting. Joy Johnson and Brian Wilton of the Governor's Authorities Unit (GAU) also participated in the meeting.

In the absence of the Chairman, the meeting was called to order by Mr. Vargas, the Vice Chairman, who requested that Ms. Kelly read the requisite notice of the meeting. Ms. Kelly announced that the meeting notice had been sent to the *Trenton Times* and *Star-Ledger* at least 48 hours prior to the meeting, and had been duly posted on the Secretary of State's bulletin board at 20 West State Street in Trenton, New Jersey. Ms. Kelly then conducted a roll call and indicated that a quorum of the Members was present.

Pledge of Allegiance

Led by the Vice Chairman, the Members and all assembled stood and recited the Pledge of Allegiance.

Approval of Meeting Minutes

Mr. Vargas presented for consideration and approval the minutes of the Board's September 4, 2019 Open Session meeting. A copy of the meeting minutes and a resolution had been provided to the Members for review in advance of the meeting. Upon motion duly made by Mr. Luckie and seconded by Mr. Kanef, the Open Session meeting minutes of the September 4, 2019 SDA Board meeting were approved by the Board upon the Members' unanimous vote in favor of the resolution attached hereto as *Resolution 4a*.

Authority Matters

CEO Report

The Vice Chairman asked Interim Chief Executive Officer (CEO) Manuel Da Silva for the Report of the CEO. Mr. Da Silva introduced Deputy Chief Counsel Brian Wilton and Associate Counsel Joy Johnson of the Governor's Authorities Unit. He noted that Ms. Johnson will be replacing Adam Sternbach as the Authority's liaison to the GAU.

Next, Mr. Da Silva gave an update on the September 2019 school openings. He reported that the Authority opened four new schools last month representing over \$300 million in project

costs, 4,182 new seats and 680,000 square feet of new school. He added that the four schools are all occupied.

Mr. Da Silva then discussed the 14 remaining capital plan projects. With respect to projects in design, he said that for the Paterson Union Avenue MS project, design phase services are ongoing. He added that piles, foundations and steel were released by the Department of Community Affairs (DCA) the previous week.

Turning to projects in the procurement stage, Mr. Da Silva reported that for the Perth Amboy HS project, proposals are due this month and staff anticipates advancing a recommendation of award to the Board in November. For the Keansburg Port Monmouth Road School, he said that staff received proposals from four firms in September for general contracting services and, separately, from thirteen firms for construction management services. He added that staff anticipates advancing recommendations of award to the Board in November for both general contracting services and construction management services. In regard to the Plainfield Woodland ES project, he advised that staff advertised for design-build services at the end of August and proposals are due in November.

Mr. Da Silva gave an update on projects in the constructability stage. He said that for the Orange Cleveland Street ES and Orange HS projects, the constructability review phase is proceeding on schedule.

With respect to design-build projects in construction, Mr. Da Silva informed the Members that for the Camden HS project, design phase services and structural steel work continues in the building. For the East Orange George Washington Carver ES project, he said that the design-builder has completed design phase services. He added that interior mechanical, electrical and plumbing finish work is ongoing. He reported that for the Harrison New ES

project, mechanical, electrical and plumbing (MEP) rough-in enclosure are ongoing, as well as exterior masonry veneer construction, roofing and window installation activities.

In continuing, Mr. Da Silva said that for the Millville HS addition and renovation project, design phase services continue. He advised that Phase II addition masonry and MEP rough-in activities and Phase III footings and foundation work is ongoing. For the Passaic Dayton Avenue Educational Campus project, he reported that Terminal Construction has completed all slabs on decks and commenced exterior framing of upper floors to advance roof installation. He noted that staff anticipates the issuance of the full notice-to-proceed (NTP) with construction this month. In regard to the Pemberton Denbo Crichton ES project, he advised that the SDA has issued the full NTP. He added that all interior work is underway.

Next, Mr. Da Silva reported on projects in the programming stage. He said that for the Hoboken Demarest ES project, staff held a design services kickoff meeting. For the Union City New Grade 7 to 9 School project, he reported that SDA in-house design development is ongoing.

Mr. Da Silva gave an update on SDA grant activity. He advised the Members that, as of August 2019, 13 grants impacting 9 districts were closed out during the reporting period, representing \$19.4 million in total project costs and a state share of \$8.6 million.

With respect to emergent projects, Mr. Da Silva said that there are 6 active projects scheduled with substantial completion by the end of 2019 and total project costs of \$4.37 million.

Turning to Authority events, outreach and other activities, Mr. Da Silva informed the Members that on September 5, SDA joined Passaic students and officials for a ribbon cutting ceremony on the first day of school at the Sonia Sotomayor School No. 21. He said it was a great day and SDA staff was happy that Passaic Mayor Lora, Assemblyman Schaer and Assemblyman Calabrese were there to participate in the event.

Mr. Da Silva reported that on September 6, the SDA joined the Trenton School District for a ribbon cutting ceremony for the new High School. He said that it was a wonderful event which was attended by Chairman Nixon and Board Member Michael Maloney. He added that on Monday, September 9, a few SDA staff members were also at TCHS for the first day of school. He said students walked down a red carpet to the gymnasium. He added that all 1,850 students were cheering and singing.

Mr. Da Silva said that on September 19, the SDA joined the Irvington School District for a ribbon cutting ceremony for the new Madison Avenue ES. He added that Irvington Mayor Vauss attended the event, noting that it was a great event.

Mr. Da Silva reported that on September 24, SDA celebrated the last of the 4 ribbon cuttings at the new Rosa M. Lopez ES. He said that Assembly Speaker Coughlin, Assemblywoman Lopez and Mayor Diaz were in attendance.

Audit Committee

Mr. Vargas asked Mr. Kanef to provide the report of the Audit Committee. Mr. Kanef reported that the Audit Committee met on September 16, 2019 at which time management provided the Committee with the August 2019 New Funding Allocation and Capital Plan Update. He advised that, during the reporting period, there were no changes in any of the reserve balances for the SDA districts. He informed the Members that the reserve balance for the Regular Operating Districts (RODs) increased by \$400,000 during the reporting period due to a reduction in state share for grant projects nearing completion.

Next, Mr. Kanef advised the Board that the Committee was provided with the results of an audit that was conducted to comply with the statutory requirement that capital portfolio projects over \$10 million be reviewed to assess whether state funds were expended in accordance with contract terms, SDA practices and state regulations. He reported that there were no adverse

findings, adding that the audit revealed that State funds utilized for the project were expended prudently and consistent with legal requirements.

Mr. Kanef then provided the August 2019 Monthly Financial Report. He advised the Committee that the Authority's operating expenses (Actual vs. Budget) for the year-to-date period totaled \$12.2 million, \$1.6 million lower as compared to the budget for the corresponding period. He explained that the decrease is mainly attributable to lower personnel costs. He reported that operating expenses (Actual vs. Prior-year Actual) for the year-to-date period, at \$12.2 million, are approximately \$784,000 higher compared to the operating budget for the corresponding prior year period--largely attributable to the 2018 Authority restructuring. Mr. Kanef added that the Authority is projecting that this increase will gradually dissipate over the remaining months of the year due to the staff reduction in July 2019. Mr. Kanef then reported that school facilities project expenditures (Actual vs. Forecast) for the year-to-date period total \$200.5 million, \$13.7 million lower as compared to the capital spending forecast for the corresponding period. He advised that this variance is the result of lower than forecasted expenditures for grant activity and design services—net of cost recovery settlements, property acquisitions, lower spending on project management and other project related costs. He noted that this variance is offset by spending increases in construction activity. Mr. Kanef then reported that project expenditures (Actual vs. Prior Year Actual), at \$200.5 million, are \$15.7 million lower as compared to the corresponding prior year period. He explained that the variance is due to decreased grant activity, project insurance costs and design services – net of cost recovery settlements, and other project related costs. He reported that this decreased spending is offset by an increase in spending for construction work and school furniture purchases. He said that, since program inception, approximately 84.8% of the funds authorized for SDA districts have been disbursed. Additionally, he said that, since program inception, 96%

of all SDA disbursements relate to school facilities projects, while 4% relate to operating expenses. He advised that the estimated value of active school facilities capital, emergent and regular operating district grant projects is approximately \$2 billion.

Mr. Kanef then advised that management presented the Committee with a personnel report in accordance with the September 4, 2019 approved amendments to the SDA Bylaws and Audit Committee Charter.

Next, Mr. Kanef advised that 1 item was discussed by the Committee that requires Board action. He said that management presented a proposed Legal Services Award (the Award). Referencing a memorandum that was distributed to the Members in advance of the meeting, he explained that management recommended, and the Committee is advancing for approval, awards to law firms with expertise in seven (7) areas. He listed those areas as: 1) Bankruptcy & Insolvency Proceedings; 2) Environmental Law; 3) Employment Law; 4) Government Contracting, Bid Protests & Procurement; 5) Professional Errors & Omissions & Cost Recovery; 6) Construction Litigation; and 7) Real Estate Law. He said that the Board is requested to approve the proposed award of contracts to 13 firms to provide these services following a competitive procurement process. He noted that these services were similarly procured by the SDA on five (5) prior occasions beginning in 2008 to complement the legal support provided to the Authority through its Office of Chief Counsel and by the Division of Law in the Office of the Attorney General. He advised that the services will be performed for a blended hourly rate of \$200 per hour for attorneys and \$90 per hour for paralegals for the two-year term. He advised the Board that no one firm can be compensated in excess of \$1,500,000 over the term of the engagement, regardless of whether it's engaged in one or more of the specialty areas. Mr. Kanef noted that these are the same terms SDA utilized in the previous procurements.

A resolution pertaining to this matter was provided to the Board for review in advance of the meeting. Upon a motion duly made by Mr. Luckie and seconded by Mr. Burgos, the Board approved the proposed contract awards for legal services with its unanimous vote in favor of *Resolution 6a*.

School Review Committee

Notification of Completion of Pre-Design Phase Services and Authorization to Proceed with Design Phase Services - Newark Public School District - Ivy Hill Elementary School - Boiler Room Vault Emergent Project - [INFORMATIONAL]

Mr. Vargas asked Mr. Luckie to provide the report of the School Review Committee. Mr. Luckie reported that the School Review Committee met on September 16, 2019 at which time one informational item was discussed in Open Session. He explained that management is advancing an emergent project at the Newark Ivy Hill ES to address a structural issue and water infiltration issues in the sub-surface boiler vault room. He reported that DRG Architects (DRG) was engaged by the SDA through the design consultant services task order contract to perform pre-design phase services, inclusive of investigation and testing, in order to provide SDA with options for addressing the conditions. He noted that SDA staff will then determine which option to advance. Mr. Luckie said that the design consultant task order engagement, with Board approval, does not provide for or require staff to come to the Board to advance within the phases of that engagement. He added that, this memorandum is presented to the Board to inform the Members that staff will select an option based upon the pre-design work and that all of the options will be for dollar amounts greater than \$500,000. He explained that management will later come to Board for approval because the recommendation toward construction after procurement will be a for a dollar value that will require Board approval.

Public Comments

Mr. Vargas then opened the Public Comments portion of the meeting. No member of the public stepped forward to address the Board.

The Vice Chairman then announced that the Board would be adjourning into Executive Session. Ms. Kelly said that the Board had resolved to adjourn into Executive Session discuss a contractual matter regarding the Millville HS project. She said that no formal action would be taken regarding this item.

Thereafter, upon motion by the Vice Chairman and with unanimous consent, the meeting adjourned into Executive Session.

DATE: November 6, 2019

INTRODUCTION

The purpose of this memorandum is to request Board approval to modify the Memorandum of Understanding ("MOU") between the New Jersey Schools Development Authority ("NJSDA") and the New Jersey Higher Education Student Assistance Authority ("HESAA"). Specifically, management is seeking to modify the calculation for future reimbursable HESAA Administrative Fees beginning with the 2019-2020 academic year. A draft copy of Addendum No. 3 to the MOU, which contains the proposed change, is included in Attachment A to this memorandum. Management is also seeking the Board's approval to formally increase the funding for previously billed HESAA Administrative Fees paid by NJSDA related to the 2016-2017, 2017-2018 and 2018-2019 academic school years. Although the amounts billed by HESAA are consistent with the terms of the MOU, the billings exceeded the amounts authorized previously by the NJSDA Board.

The MOU was originally executed on July 31, 2013, and extensions were subsequently approved by the NJSDA Board on July 6, 2016 and June 5, 2019, the latter of which extended the MOU term through May 1, 2022. Under the MOU, NJSDA provides funds for the HESAA administered Governor's Industry Vocations Scholarship Program ("NJ-GIVS").

BACKGROUND

The proposed new methodology for calculating HESAA Administrative Fees would require HESAA to invoice NJSDA at a flat 10% rate applied to the amount of scholarships awarded during a particular academic year. Currently, HESAA invoices NJSDA for fully-documented and actual administrative expenses, subject to maximum spending limits specified in the MOU; however, the level of effort associated with collecting, authenticating, and reviewing "actual costs" has proven to be burdensome for both entities and has resulted in delays in invoicing by HESAA. This change, for which Board approval is being requested, is included in Addendum No. 3.

Additionally, as discussed above, separate from Addendum No. 3 Board approval is being requested to formally increase the authorized funding for previously billed HESAA Administrative Fees paid by NJSDA related to the 2016-2017, 2017-2018 and 2018-2019 academic school years, as follows:

Members of the Authority MOU Between NJSDA and HESAA November 6, 2019

On June 5, 2013, the Board initially allocated \$550,000.00 (\$500,000.00 to be awarded in scholarships to eligible students and up to \$50,000.00 for HESAA Administrative Fees) for the first year of the NJ-GIVS program; however, since actual expenditures in year one of the scholarship program were significantly below the \$550,000.00, the Authority transferred the unused balance to year two of the program, and then did the same in year three of the program as an unused balance still remained.

On July 6, 2016, upon recommendation by the Audit Committee, the Board approved a three-year extension of the program from May 1, 2016 to May 1, 2019 with an annual budget for an amount not to exceed \$250,000.00 (\$227,300.00 that could be awarded in scholarships to eligible students and up to \$22,700.00 for HESAA Administrative Fees).

On June 5, 2019, upon recommendation by the Audit Committee, the Board approved a three-year extension of the program from May 1, 2019 to May 1, 2022 with an annual budget for an amount not to exceed \$250,000.00 (\$227,300.00 that could be awarded in scholarships to eligible students and up to \$22,700.00 for HESAA Administrative Fees).

Since July 2, 2013, HESAA has invoiced the Authority a total of approximately \$1,321,230 for the scholarship program, including \$142,318 for HESAA administrative fees. NJSDA and HESAA together have awarded scholarships to over 650 students, which has furthered their education across various institutions of higher education throughout the state.

NJ-GIVS PROGRAM

NJ-GIVS fills a void in state financial aid programs by making scholarships available to women and minority students pursuing non-degree certificate programs in construction/engineering related industries. Prior to the implementation of NJ-GIVS, state student financial aid programs only provided grants and scholarships to students in matriculated Associate or Baccalaureate degree programs.

Women and minority students from all counties and municipalities in New Jersey are eligible to receive a NJ-GIVS scholarship. Consistent with other HESAA residency requirements, students must be bona fide New Jersey residents for a period of at least 12 months. Students admitted to an approved institutional program must apply directly to HESAA for the scholarship. HESAA awards the funds to eligible students on a "first come first served" basis.

A scholarship covers the cost of tuition up to \$2,000 per year less any federal financial aid the student is eligible to receive. The scholarship is renewable for one year. All scholarship awards are made to the institutions. The institutions, in turn, credit the students' accounts. No funds are disbursed directly to students.

HESAA

Like SDA, HESAA is an independent state authority. HESAA is charged with administering the state's higher education need-based grants and merit scholarships. Annually, HESAA distributes over \$330 million to over 70,000 students attending New Jersey colleges or universities. HESAA administers the Tuition Aid Grant (TAG) program, the nation's most generous need-based undergraduate aid program; the part-time TAG for County College Students Program; the NJ STARS program; and the NJ STARS II program. Additionally, HESAA has bonding authority and annually sells bonds to finance the New Jersey College Loans to Assist State Students (NJCLASS) program. Along with the state programs, HESAA has

contracts with the U.S. Department of Education to administer a number of federal student aid programs including, but not limited to, the Federal Family Education Loan Program and the John R. Justice Loan Redemption Program. In addition to administering financial aid programs, HESAA also has regulatory oversight over the college and university financial aid offices and conducts audits of those offices' functions to make certain the expenditure of funds comports with all statutory and regulatory requirements.

RECOMMENDATION

The Members of the Authority are requested to approve Addendum No. 3 to the Memorandum of Understanding between the New Jersey Schools Development Authority and the New Jersey Higher Education Student Assistance Authority. A draft copy of the proposed addendum is included as Attachment A.

Additionally, the Members of the Authority are requested to approve the additional funds required to cover all excess HESAA Administrative Fees billed for the 2016-2017, 2017-2018 and 2018-2019 academic school years. The total amount of additional funds required is \$30,444.53.

In accordance with the Operating Authority adopted by the Board on December 1, 2010, as amended March 7, 2012, any amendment (including amendments to MOUs/MOAs) which exceeds \$100,000 or 10% of the contract value requires approval by the Members of the Authority. Although this amendment does not exceed \$100,000 or 10% of the contract value, management is nonetheless seeking Board approval since the Operating Authority requires Board approval of all MOUs/MOAs.

MEMORANDUM OF UNDERSTANDING BETWEEN THE NEW JERSEY SCHOOLS DEVELOPMENT AUTHORITY AND THE NEW JERSEY HIGHER EDUCATION STUDENT ASSISTANCE AUTHORITY ADDENDUM NO. 3

This serves to amend the terms and conditions of the Memorandum of Understanding ("MOU") dated July 31, 2013 made by and between the New Jersey Schools Development Authority ("SDA") and the New Jersey Higher Education Student Assistance Authority ("HESAA"), which sets forth the understanding of the parties with respect to the funding and administration of the Governor's Industry Vocations Scholarship ("NJ-GIVS") Program. Pursuant to the MOU, HESAA administers the NJ-GIVS Program, including the award and disbursement of scholarships, and SDA funds the scholarships and reimburses HESAA for the costs associated with administration of the NJ-GIVS Program, both of which are subject to the limits delineated in the MOU.

The MOU between SDA and HESAA has been extended twice through successive amendments, with the previous amendment, dated July 19, 2019, extending the term for an additional three years from May 1, 2019 through May 1, 2022. SDA and HESAA now agree to modify the MOU through this Addendum. Except as modified by this Addendum, all other terms and conditions of the MOU shall remain in full force and effect.

SDA and HESAA agree to revise the methodology and calculation for future reimbursable HESAA Administrative Fees, beginning with Administrative Fees billed for Academic Year 2019-2020, by replacing paragraph 4. of the SDA Responsibilities section of the MOU with the following:

SDA Responsibilities:

4. <u>HESAA Administrative Fee</u> – SDA agrees to reimburse HESAA for expenses associated with administering, implementing, and promoting the NJ-GIVS Program at a flat 10% rate applied to the amount of scholarships awarded during a particular academic year or semester. Such reimbursement application shall be submitted by HESAA concurrent with SDA's funding of student scholarships.

INTRODUCTION

I am writing to recommend approval by the Members of the Authority of the award of a contract for Construction Management (CM) Services. This contract is for services to manage the Port Monmouth Road School Addition and Renovation construction project in the Keansburg School District.

Pursuant to the NJSDA Operating Authority adopted by the Board on December 1, 2010, as amended March 7, 2012, Board approval is required for the award of consultant contracts greater than \$100,000. Funding for this engagement is provided within the Project Budget as presented in the respective Final Project Charter presented for approval by the Members today.

BACKGROUND

The Port Monmouth Road School Addition and Renovation Project will result in a School Facility of approximately 47,000 total square feet designed to educate 315 Pre-Kindergarten students. The school is comprised of three distinct areas identified as Wings A, B and C. Wings B and C are permanent building structures constructed in 1992 and 1968 respectively while Wing A is modular construction built in 1973. The Project includes abatement of hazardous materials; demolition of Wing A; renovation of approximately 18,930 square feet of the existing School Facility including classrooms, gross motor skills area and support facilities; construction of a single-story addition of approximately 27,580 square feet containing classrooms, a food service area, nurse's area, support facilities and connection to the renovated facility; selective facility conditions improvements including a new HVAC system, fire protection system, building envelope repairs and other systems upgrades; and site improvements including required outdoor physical education/play areas and flood prevention improvements.

We are separately seeking the Members' approval of the award for General Construction Services and the approval of the Final Project Charter.

PROCUREMENT PROCESS

This procurement package for CM Services was advertised as a "Price and Other Factors" solicitation beginning on August 14, 2019 on the NJSDA website, NJ State website, and in selected newspapers for interested firms to participate in the bidding process. In addition, the advertisement was distributed to those firms that are pre-qualified in the area of Construction Management (P029) by both the Department of Treasury-Division of Property Management and Construction and the NJSDA. For this project procurement, price was weighted as 40% of the Final Combined Score, and all non-price other factors were weighted as 60% of the Final Combined Score.

A Selection Committee consisting of five NJSDA staff members was established.

Responsive proposals were received from thirteen (13) firms by September 17, 2019. Qualifications and Technical Proposals were evaluated by the Selection Committee. Evaluations were based upon the information provided by the firms in response to the RFQ/RFP for this project. The committee members evaluated the Qualifications and Technical Proposals for Construction Management Services separately based on the following criteria:

- Firm's CM Experience on Similarly Sophisticated Projects
- Staffing Proposal
- Key Team Members' Experience on Similarly Sophisticated Projects

Each Selection Committee member evaluated each Qualifications and Technical Proposal, assigning a raw score for each criterion on a scale of 0 to 10 as follows:

- Outstanding (9-10): depth and quality of response offers significant advantages.
- Superior (7-8): exceeds RFQ/RFP requirements with no deficiencies.
- Sufficient (5-6): meets RFQ/RFP requirements with no significant deficiencies.
- Minimal (3-4): meets RFQ/RFP requirements but contains some significant deficiencies.
- Marginal (1-2): comprehends intent of RFQ/RFP but contains many significant deficiencies.
- Unsatisfactory (0): requirements not addressed and lack of detail precludes adequate evaluation.

Weighting factors were applied to each of the Selection Committee member's raw scores for each criterion to arrive at a total weighted score as indicated in Table 1 below:

For each firm's Qualifications and Technical Proposal, the individual criteria scores awarded by a particular Selection Committee member were added together to calculate a score for that Qualifications and Technical Proposal. The maximum score for a Qualifications and Technical Proposal is 100. All of the scores awarded by the Selection Committee members to a particular firm's Qualifications and Technical Proposal were added together and averaged to arrive at a Final Qualifications and Technical Proposal Score for each firm. The responsive firms, their scores and rankings are listed in Table 2 below:

The RFQ/RFP stipulated that a shortlist of the six (6) highest-ranked firms would be determined based on the Final Qualifications and Technical Proposal Scores. The shortlisted firms participated in interviews with the Selection Committee on October 4, 2019. The interviews allowed the firms to expand and detail their firm and team experience with respect to NJSDA requirements for construction management services. The Selection Committee interviewed each of the shortlisted firms and evaluated each firm on Interview Criteria and Weighting Factors that were the same as those used in the evaluation of the Qualifications and Technical Proposals, as detailed above.

The individual criteria scores awarded by a particular Selection Committee member were added together to calculate an Interview Score for that firm. The maximum Interview Score is 100. All of the Interview Scores awarded to a particular firm by the Selection Committee members were added together and averaged to arrive at a Final Interview Score for each firm. The shortlisted firms, their scores and rankings are listed in Table 3 below:

The Final Interview Score for each shortlisted firm was added to the Final Qualifications and Technical Proposal Score for each such firm, and the two scores were averaged to arrive at a Non-Price Score for each shortlisted firm. The maximum Non-Price Score is 100. The shortlisted firms, their scores and rankings are listed in Table 4 below:

Once all the Non-Price Scores for all shortlisted firms were calculated, the NJSDA opened the sealed Price Proposals and reviewed them for responsiveness. The Price Proposals were publicly opened on October 9, 2019, and the bids were read aloud as required by law.

The lowest responsive Price Proposal was awarded the maximum number of points for the price component, which is 100. All other Price Proposals were awarded points based on the percentage that each proposal exceeded the lowest bid.

The results of the NJSDA's review and scoring of the Price Proposals are listed in Table 5 below:

After the Price Scores were determined for all shortlisted firms, the Price Scores were adjusted by a weighting factor of 40%. The Non-Price Scores for "Other Factors" criteria were adjusted by a weighting factor of 60%. The Price Scores and Non-Price Score for each shortlisted firm were added together for a Final Combined Score. The maximum Final Combined Score is 100. The Final Combined Scores and Final Rankings are listed in Table 6 below:

The highest ranked firm was Pinnacle Consulting & Construction Services, Inc. (Pinnacle).

The bid submitted by Pinnacle was less than the NJSDA estimate. In order to ensure the firm's Price Proposal was inclusive of all scope elements, a conference was conducted on October 15, 2019 with Pinnacle and staff from Procurement, Construction Operations, Program Operations and Financial Operations to review the bid. At the time of the review, Pinnacle confirmed that its Price Proposal is inclusive of all scope elements contained in the Contract Documents.

The Construction Operations Director and the Financial Operations Director recommend award of the project to Pinnacle Consulting & Construction Services, Inc.

RECOMMENDATION

The Members of the Authority are requested to approve the award of a contract to the firm with the highest Final Combined Score, Pinnacle Consulting & Construction Services, Inc., in the amount of \$1,065,750 for Construction Management Services for the Port Monmouth Road School Addition and Renovation project located in the Keansburg School District.

Before construction initiates, the awardee is required to perform a constructability review to identify any potential conflicts and their resulting cost impact.

We are also recommending approval by the Members of the attached Final Project Charter representing the project budget inclusive of dollar values for the award of construction, as well as a construction contingency which is intended to address, but is not limited to, any potential cost impacts which may be identified during the constructability review.

Pursuant to the NJSDA Operating Authority adopted by the Board on December 1, 2010, as amended March 7, 2012, Board approval is required for the award of construction contracts greater than \$500,000 and for the approval of the Final Project Charter.

BACKGROUND

The Port Monmouth Road School Addition and Renovation Project will result in a School Facility of approximately 47,000 total square feet designed to educate 315 Pre-Kindergarten students. The school is comprised of three distinct areas identified as Wings A, B and C. Wings B and C are permanent building structures constructed in 1992 and 1968 respectively while Wing A is modular construction built in 1973. The Project includes abatement of hazardous materials; demolition of Wing A; renovation of approximately 18,930 square feet of the existing School Facility including classrooms, gross motor skills area and support facilities; construction of a single-story addition

of approximately 27,580 square feet containing classrooms, a food service area, nurse's area, support facilities and connection to the renovated facility; selective facility conditions improvements including a new HVAC system, fire protection system, building envelope repairs and other systems upgrades; and site improvements including required outdoor physical education/play areas and flood prevention improvements.

In the August 2017 memo to the Board approving the Preliminary Charter for this project a portion of the project scope identified the need for District-owned modular units to continue serving as temporary educational facilities for the Port Monmouth Road school students. Some of those modular units are located on NJSDA-owned property that will be converted to parking area for the completed Caruso E.S. project at the conclusion of the Port Monmouth Road School Project. For these project scope phasing reasons, the Final Project Charter for the Port Monmouth Road School includes the scope and costs associated with this work which will be advertised and awarded under a separate contract near the completion of this project.

We are separately seeking the Members' approval of the award for Construction Management Services.

PROCUREMENT PROCESS

This package was advertised as a "Price and Other Factors" solicitation beginning on June 24, 2019 on the NJSDA website, NJ State website, and in selected newspapers for interested firms to participate in the bidding process. For this procurement, "Price" was weighted as more important than all "Other Factors," with price equaling 70% of the overall weight, and all non-price factors having a combined weight of 30%.

Interested bidders were required to attend the mandatory pre-bid conference held on July 9, 2019.

In accordance with regulations, the NJSDA employed a two-step process for this procurement. The first step required interested bidders to submit a Project Rating Proposal, which was used by the NJSDA to determine each bidder's Project Rating Limit, or maximum amount that a bidder may bid, for the project. Project Rating Proposals were received by July 23, 2019. Bidders were evaluated based on the largest of four projects completed in the past ten years, safety records as well as reference checks. Based on evaluation of the information submitted, eight (8) bidders received a Project Rating Limit.

The Project Rating Limits resulting from the Project Rating Evaluations are listed in Table 1 below:

The second step of the process required the bidders to simultaneously submit a Technical Proposal and a sealed Price Proposal. In advance of submission of Technical and Price Proposals, Bidders were permitted to submit questions seeking clarification of the procurement documents, until August 9, 2019. Questions were issued to the bidders on August 19, August 28 and September 6, 2019.

Technical and Price Proposals were received on September 18, 2019 from four (4) bidders. As described in the RFP, the Technical Proposal submission consists of two separate portions for evaluation by two distinct committees as follows:

- 1. The "Experience Criteria" portion of the Technical Proposal submission was evaluated by an Evaluation Committee comprised of three (3) NJSDA staff members. The Evaluation Committee was responsible for collectively evaluating the "Experience Criteria" on a non-numeric basis and determining, on a consensus basis, whether a bidder had demonstrated sufficient experience in the following "Experience Criteria" categories:
 - Bidder's Experience on Similarly Sophisticated Projects
 - Bidder's Demonstrated Prior Affirmative Action Experience
- 2. The "Project Approach Criteria" portion of the Technical Proposal submission was evaluated by a Selection Committee, comprised of five (5) NJSDA staff members and one (1) Keansburg School District representative. The Selection Committee was responsible for independently evaluating and scoring each bidder in each of the following "Project Approach Criteria" categories:
 - Approach to the Project
 - Identification and Qualifications of Required Key Team Members
 - Approach to the Constructability Review
 - Approach to the Schedule

"Evaluation Committee" Review

The Evaluation Committee determined that each of the bidders demonstrated sufficient experience in the "Experience Criteria" categories to be considered for award.

"Selection Committee" Review

The Selection Committee members conducted interviews with each of the bidders at NJSDA offices in Trenton on October 1, 2019 affording committee members an opportunity to obtain any additional information from each bidder team as needed to complete their evaluations of the "Project Approach Criteria" portion of the Technical Proposal.

Each Selection Committee member evaluated the "Project Approach Criteria" portion of each Technical Proposal, assigning a raw score for each category on a scale of 0 to 10 as follows:

- 9 10 points outstanding response offers significant advantages.
- 7 8 points superior response exceeds requirements with no deficiencies.
- 5 6 points sufficient response meets the requirements with no significant deficiencies.
- 3 4 points minimal response meets the requirements but contains some significant deficiencies.
- 1 2 points marginal response comprehends requirements, but contains many significant deficiencies.
- 0 points unsatisfactory response requirements not addressed and lack of detail precludes adequate evaluation.

Weighting factors were then applied to each of the Selection Committee member's raw scores for each "Project Approach Criteria" category to arrive at a total weighted score as follows in Table 2 below:

For each Technical Proposal, the individual "Project Approach Criteria" category scores awarded by a particular Selection Committee member were added together to calculate a total non-price score for that Technical Proposal. The maximum total non-price score is 100. All of the total non-price scores awarded to a Technical Proposal by the Selection Committee members were added together and averaged to arrive at a final non-price score for each Technical Proposal.

The results of the Selection Committee's review and scoring of the "Project Approach Criteria" portion of each Technical Proposal are listed in Table 3 below:

Sealed Price Proposals

Once all the Technical Proposals were scored pursuant to the "Project Approach Criteria", the sealed Price Proposals were publicly opened on October 3, 2019 in accordance with the RFP and the bids were read aloud as required by law.

The lowest responsive Price Proposal was awarded the maximum number of points for the price component, which is 100. All other Price Proposals were awarded points based on the percentage that each proposal exceeded the lowest bid.

The results of the NJSDA's review and scoring of the Price Proposals are listed in Table 4 below:

As stipulated in the RFP, each Bid Amount is inclusive of NJSDA-established Allowances totaling \$1,215,000, as follows: \$250,000 for Constructability Review; \$520,000 for Impacted and Unsuitable Materials; \$100,000 for Hazardous Materials and Related Activities; \$145,000 for Emergency Responder Radio System; \$100,000 for Subsurface Conditions; and \$100,000 for Security Systems Upgrade.

Final Combined Scores and Final Rankings

After the Price Scores were determined for all bidders, the Price Scores were adjusted by a weighting factor of 70%. The Non-Price Scores for "Other Factors" criteria were adjusted by a weighting factor of 30%. The weighted Price Score and weighted Non-Price Score for each bidder were added together for a Final Combined Score. The maximum Final Combined Score is 100. The Final Combined Scores and Final Rankings are listed in Table 5 below:

Highest Ranked Bidder's Price Proposal

The bid submitted by Niram was less than the CCE but was within the advertised CCE range. In order to understand the differential between the CCE and the bid price and to ensure the contractor's price proposal was inclusive of all

² The NJSDA's Price Proposal form requires bidders to represent their Total Bid Amount in both words and figures. Brockwell & Carrington's ("B&C's") Price Proposal submission indicated "Twenty Nine Million Six Hundred Twenty Nine Thousand" in words and \$21,629,000 in figures. Section E.3 of the Price Proposal form states: "In case of a discrepancy between the amount shown in words and the amount shown in figures, the amount shown in words shall govern." Therefore, the NJSDA recorded B&C's Total Bid Amount as \$29,629,000. scope elements, a conference was conducted on October 10, 2019 with Niram and staff from Procurement, Construction Operations, Program Operations, Design Studio and Financial Operations to review the bid. The discussion verified that Niram had included all project scope work in its bid and identified that variances between the NJSDA's CCE and Niram's price proposal are mostly associated with lower than NJSDA-estimated costs in the HVAC discipline and higher than NJSDA-estimated costs in the Electrical discipline. At the time of review, Niram confirmed that its price proposal is inclusive of all scope elements contained in the Contract Documents.

The Construction Operations Director and the Financial Operations Director recommend award of the project to Niram, Inc.

FINAL PROJECT CHARTER

The attached Final Project Charter represents the project budget inclusive of actual dollar values for the award of the General Construction contract, current estimates for all future scope elements such as FF&E and technology, and appropriate contingencies. Additionally, the budget is inclusive of costs incurred related to NJSDA Staff costs for both Design and Project Management. The Final Project Charter budget of \$28.4 million represents an increase of approximately \$2.5 million from the Board-approved Preliminary Project Charter due to increased construction costs based upon the award value for the general contractor which exceed the value that was estimated within the Preliminary Project Charter. The values estimated within the Preliminary Project Charter were based upon estimated costs for the proposed project scope at the time of completion of schematic design in August 2017. The increased cost is reflective of the fully developed project scope defined within the final design documents for the project. The construction award also includes approximately \$1.0 million in allowances that had not yet been identified at the time of approval of the Preliminary Project Charter.

RECOMMENDATION

The Members of the Authority are requested to approve the award of a contract to the highest ranked bidder, Niram, Inc., for Contract No. ET-0098-C01 in the amount of \$18,645,000 inclusive of NJSDA-established Allowances totaling \$1,215,000. Prior to execution of the contract, the contract and related documentation will be reviewed and approved by the NJSDA Division of Chief Counsel.

The Members of the Authority are also requested to approve the attached Final Project Charter representing all expended and projected funds necessary for completion of the project.

Pursuant to the NJSDA Operating Authority adopted by the Board on December 1, 2010, as amended March 7, 2012, Board approval is required for the award of construction contracts greater than \$500,000 and for the approval of the Final Project Charter.

BACKGROUND

The New Perth Amboy High School project will consist of the construction of an approximately 576,000 SF building to educate approximately 2,800 students in grades 9 through 12.

On June 1, 2016, the Members of the Authority approved the Preliminary Project Charter, thereby approving construction of a new high school facility and related site development work on the District-owned Convery Boulevard site utilizing in-house design and a Design-Build delivery method.

A Construction Management Firm will be engaged to manage the construction of the new Perth Amboy High School. Advertisement for the procurement of these services will initiate during the fourth quarter of 2019.

PROCUREMENT PROCESS

This package was advertised as a design-build solicitation beginning on March 26, 2019 on the NJSDA website, NJ State website, and in selected newspapers for interested firms to participate in the bidding process. For this procurement, "Price" was weighted as more important than all "Other Factors," with price equaling 60% of the overall weight, and all non-price factors having a combined weight of 40%.

Interested bidders were required to attend a mandatory pre-bid conference and site visit held on April 9, 2019.

In accordance with regulations, the NJSDA employed a two-step process for this procurement. The first step required interested bidders to submit a Project Rating Proposal, which was used by the NJSDA to determine each bidder's Project Rating Limit, or maximum amount that a bidder may bid, for the project. Project Rating Proposals were received by April 23, 2019. Bidders were evaluated based on the largest of four projects completed in the past ten years, safety records as well as reference checks. Based on evaluation of the information submitted, six (6) bidders received a Project Rating Limit.

The Project Rating Limits resulting from the Project Rating Evaluations are listed in Table 1 below:

The second step of the process required the bidders to simultaneously submit a Technical Proposal and a sealed Price Proposal. Technical and Price Proposals were received on October 8, 2019 from two (2) bidders. As described in the RFP, the Technical Proposal submission consists of two separate portions for evaluation by two distinct committees as follows:

- 1. The "Experience Criteria" portion of the Technical Proposal submission was evaluated by an Evaluation Committee comprised of three (3) NJSDA staff members. The Evaluation Committee was responsible for collectively evaluating the "Experience Criteria" on a non-numeric basis and determining, on a consensus basis, whether a bidder had demonstrated sufficient experience in the following "Experience Criteria" categories:
 - Design-Builder's Experience on Similarly Sophisticated Projects
 - Design-Builder's Design Consultant's Experience on Similarly Sophisticated Projects
 - Design-Builder's Demonstrated Prior Affirmative Action Experience
- 2. The "Project Approach Criteria" portion of the Technical Proposal submission was evaluated by a Selection Committee, comprised of five (5) NJSDA staff members and one (1) alternate, and one (1) Perth Amboy School District representative and one (1) alternate. The Selection Committee was responsible for independently evaluating and scoring each bidder in each of the following "Project Approach Criteria" categories:
 - Approach to Project
 - Identification and Qualifications of Required Key Team Members
 - Approach to Schedule
 - Approach to LEED Requirements

"Evaluation Committee" Review

The Evaluation Committee determined that each of the bidders demonstrated sufficient experience in the "Experience Criteria" categories to be considered for award.

"Selection Committee" Review

The Selection Committee members conducted interviews with each of the two (2) Design-Build teams at NJSDA offices in Trenton on October 16, 2019 affording committee members an opportunity to obtain any additional information from each bidder team as needed to complete their evaluations of the "Project Approach Criteria" portion of the Technical Proposal.

Each Selection Committee member evaluated the "Project Approach Criteria" portion of each Technical Proposal, assigning a raw score for each category on a scale of 0 to 10 as follows:

- 9 10 points outstanding response offers significant advantages.
- 7 8 points superior response exceeds requirements with no deficiencies.
- 5 6 points sufficient response meets the requirements with no significant deficiencies.

- 3 4 points minimal response meets the requirements but contains some significant deficiencies.
- 1 2 points marginal response comprehends requirements, but contains many significant deficiencies.
- 0 points unsatisfactory response requirements not addressed and lack of detail precludes adequate evaluation.

Weighting factors were then applied to each of the Selection Committee member's raw scores for each "Project Approach Criteria" category to arrive at a total weighted score as follows in Table 2 below:

For each Technical Proposal, the individual "Project Approach Criteria" category scores awarded by a particular Selection Committee member were added together to calculate a total Non-Price Score for that Technical Proposal. The maximum total Non-Price Score is 100. All of the total Non-Price Scores awarded to a Technical Proposal by the Selection Committee members were added together and averaged to arrive at a final Non-Price Score for each Technical Proposal.

The results of the Selection Committee's review of the "Project Approach Criteria" portion of each Technical Proposal are listed in Table 3 below:

Sealed Price Proposals

Once all the Technical Proposals were scored pursuant to the "Project Approach Criteria", the sealed Price Proposals were publicly opened on October 18, 2019 in accordance with the RFP and the bids were read aloud as required by law.

The lowest responsive Price Proposal was awarded the maximum number of points for the price component, which is 100. All other Price Proposals were awarded points based on the percentage that each proposal exceeded the lowest bid.

The results of the NJSDA's review and scoring of the Price Proposals are listed in Table 4 below:

As stipulated in the RFP, each Bid Amount is inclusive of NJSDA-established Allowances totaling \$5,620,000, as follows: \$2,200,000 for General Design and Construction; \$400,000 for Emergency Responder Radio Repeater System; \$650,000 for Emergency Generator upgrades for additional electrical load requirements to the System requested and to be funded by the District; \$210,000 for Emergency Alert System funded in part by the District to address system features that exceed statutory requirements; \$2,010,000 for Subsurface Conditions for unforeseen environmental or geotechnical issues beyond those identified in the Contract; \$100,000 for Outdoor School Sign for district funded electronic displays and School mascot sculpture; and \$50,000 for Domestic Water Conditioning if necessary to address acceptable pH Levels.

Final Combined Scores and Final Rankings

After the Price Scores were determined for all bidders, the Price Scores were adjusted by a weighting factor of 60%. The Non-Price Scores for "Other Factors" criteria were adjusted by a weighting factor of 40%. The weighted Price Score and weighted Non-Price Score for each bidder were added together for a Final Combined Score. The maximum Final Combined Score is 100. The Final Combined Scores and Final Rankings are listed in Table 5 below:

The highest ranked bidder was Terminal/Dinallo JV.

Highest Ranked Bidder's Price Proposal

The bid submitted by Terminal/Dinallo JV was \$26,850,000 greater than the CCE. In order to understand the differential between the CCE and the bid price and to ensure the contractor's price

proposal was inclusive of all scope elements, a conference was conducted on October 23, 2019 with Terminal/Dinallo JV and staff from Procurement, Construction Operations, Program Operations, Design Studio and Financial Operations to review the bid. The discussion verified that Terminal/Dinallo JV had included all project scope work in its bid and identified variances between the NJSDA's CCE and Terminal/Dinallo JV's price proposal. The most significant variance was attributable to costs associated with the Electrical and HVAC work. In review with the contractor it was identified that due to the duration of the project and the timing of advancement of the Electrical and HVAC work additional cost escalation beyond that which was included within the CCE was applied by the bidders for these major trades. In addition, the contractor's bid value for electrical labor was greater than the NJSDA estimate for the work. At the time of review, Terminal/Dinallo JV confirmed that its price proposal is inclusive of all scope elements contained in the Contract Documents.

The Construction Operations Directors and the Financial Operations Director recommend award of the project to Terminal/Dinallo JV.

FINAL PROJECT CHARTER

The attached Final Project Budget represents the project budget inclusive of actual dollar values for the award of the Design-Build contract, current estimates for all future scope elements such as FF&E and technology, and appropriate contingencies. Additionally, the budget is inclusive of costs incurred related to site investigation, as well as NJSDA Staff costs for both Design and Project Management. The Final Project Charter budget of \$283.8 million represents a net increase of approximately \$49.5 million from the Board-approved Preliminary Project Charter due to increased construction costs based upon the award value for the design-builder which exceeds the value that was estimated within the Preliminary Project Charter. The values estimated within the Preliminary Project Charter were based upon the application of planning assumptions to proposed project scope at the time the charter was advanced for approval in June 2016. The increased construction cost is attributable to costs associated with the necessary deep pile foundation system required for the project as well as cost escalation. Additionally, the CM Fee budget has been increased to reflect more recent project experience.

RECOMMENDATION

The Members of the Authority are requested to approve the award of a contract to the highest ranked bidder, Terminal Construction Corporation / Dinallo Construction Corporation (JV), for Contract No. ET-0099-B01 in the amount of \$ 247,950,000 inclusive of NJSDA-established Allowances totaling \$5,620,000. Prior to execution of the contract, the contract and related documentation will be reviewed and approved by the NJSDA Division of Chief Counsel.

The Members of the Authority are also requested to approve the attached Final Project Charter representing all expended and projected funds necessary for completion of the project.

Budget Variance Analysis:

The project budget represents a net increase of approximately \$49.5 million from the Board approved Preliminary Project Charter due to increased construction costs based upon the award value for the design-builder which exceeds the value that was estimated within the Preliminary Project Charter. The values estimated within the Preliminary Project Charter were based upon the application of planning assumptions to proposed project scope at the time the charter was advanced for approval in June 2016. The increased construction cost is attributable to costs associated with the necessary deep pile foundation system required for the project as well as cost escalation. Additionally, the CM Fee budget has been increased to reflect more recent project experience. These increases are partially offset through the utilization of design contingency included within the Preliminary Project Charter to account for potential cost increases prior to the award of the design-build contract.

INTRODUCTION

I am writing this memorandum to provide notification to the Members of the Authority of the conclusion of Pre-Design Phase Services and the initiation of Design Phase Services to address an emergent condition at the Bridgeton High School in Bridgeton. The NJSDA has issued an authorization to proceed to USA Architects, Planners + Interior Designers, PA (USA) for Design Phase Services in accordance with contract provisions and based upon the NJSDA's determination of the appropriate scope of remedial work following a review of the results of the Pre-Design Phase Services performed by USA.

The NJSDA has authorized USA to complete design documents to address the emergent condition by replacing the existing roof system (excluding the Library roof), with a new Ethylene-Propylene-Diene Monomer (EPDM) roofing system and associated roofing masonry repairs consistent with NJSDA and District standards. Upon completion of the design documents the NJSDA will engage a general contractor through the Design-Bid-Build procurement process to perform the necessary construction services work to implement the design. The value of that Bid-Build engagement is estimated at this time at approximately \$5,000,000.

While advancement of the Design Phase Services did not require approval by the Board, the construction contract, based upon its estimated value, will require Board approval prior to engagement of the general contractor. Therefore, I am writing to notify the Board of the action taken.

BACKGROUND

The Bridgeton H.S., built in 1958, is an approximately 170,000 square foot facility in the Bridgeton Public School District educating approximately 1,298 students in grades 9 through 12.

The NJSDA engaged USA through utilization of the Design Consultant Services Task Order Contract and authorized USA to perform Pre-Design Phase Services inclusive of investigation and testing in order to provide the NJSDA with recommendations for addressing the Emergent Condition. Investigation and testing results clearly revealed that making selective repairs to the roof would be ineffective. Eliminating that option left installation of which type of replacement

roof system as the remaining decision. Each option considered would include complete removal of the existing system and installation of new insulation and membrane as well as replacement of all metal copings, edges, and flashings.

Based upon the results of the Pre-Design Phase Services and the NJSDA's review of USA's Conditions Assessment and Options Development Reports, the NJSDA has determined that the appropriate scope of work includes replacement of the existing roof system of approximately 160,000 square feet (excluding the Library roof), with a new EPDM roofing system and associated roofing masonry repairs consistent with NJSDA and District standards. This option will provide long-term stability, address the water infiltration condition, and provide a roofing system that is both consistent with District and NJSDA standards and at a reasonable cost. Other options were eliminated due either to application concern regarding odors, inability to address the entirety of the emergent condition, or inconsistency with NJSDA and District standards.

It is anticipated that the Design Phase will be completed by April, 2020, inclusive of review and release by the New Jersey Department of Community Affairs, followed by the procurement of the General Contractor in the 2nd Quarter of 2020. The construction work is forecasted to begin in Summer 2020 and conclude by May, 2021.

NOTIFICATION TO THE MEMBERS OF THE AUTHORITY

For the reasons discussed above, the NJSDA has authorized USA to perform Design Phase Services for the Bridgeton High School emergent project.

Advancement of these Design Consultant Services has authorized USA to complete design documents for the emergent project. Upon completion of the design documents the NJSDA will engage a general contractor through the Design-Bid-Build procurement process. The value of that general contractor engagement is estimated at this time at \$5,000,000.

While advancement of the Design Phase Services does not require approval by the Board, the construction contract will require Board approval prior to engagement of the contractor.

Compliance with Alyssa's Law, N.J.A.C. 19:32A

On February 6, 2019, Governor Murphy signed P.L. 2019, c. 33, Alyssa's Law, requiring that each public elementary and secondary school building in the state be equipped with a panic alarm to alert law enforcement in the event of a school security emergency. Alyssa's Law provided that funding for compliance with the panic alarm requirement would be made available through the proceeds of bonds issued under the Securing Our Children's Future Bond Act, P.L. 2018 c. 119. Alyssa's Law further required that the New Jersey Schools Development Authority adopt regulations, to be effective immediately upon filing and for a period of six months, thereafter to be formally amended or adopted, to establish a program to effectuate the purposes of Alyssa's Law. NJSDA, in conjunction with the Commissioner of the Department of Education (the "Commissioner") has developed rules for implementing a program to allow NJSDA to assess school districts' compliance with the requirements of Alyssa's Law with respect to each school building in a district, which will facilitate the Commissioner's program of school security project grants available for school security projects such as the installation of a panic alarm or other alternate emergency mechanism at any school building that is not already in compliance with the provisions of Alyssa's Law.

Management of the Authority now seeks the Members' approval of the filing of a Notice of Special Adoption and Concurrent Proposal of the attached rules, captioned "Procedures for Compliance with Alyssa's Law." Once the Notice of Special Adoption and Concurrent Proposal is filed with the Office of Administrative Law, Rules Division, it will effect the immediate adoption of the rules, with no public comment period, for a period of six months; and it will simultaneously propose such rules for publication and public comment to facilitate adoption of the rules in the normal course, effective for a standard seven-year expiration period upon final adoption.

Background

The Rules address the standards for school districts to demonstrate compliance with Alyssa's Law. The Rules prescribe a mandatory process in which school districts must submit to the Authority proof that each of the school buildings in the school district are equipped with a panic alarm meeting the requirements of Alyssa's Law, or an alternate emergency mechanism that, if approved by the Department of Education, will satisfy the requirements of Alyssa's Law. Alternatively, if a school district cannot demonstrate compliance with Alyssa's Law in all of the school buildings in the district, the Rules require the school district to submit to the Authority a compliance plan describing how the school district will achieve compliance with Alyssa's Law in each school building in the district, which may include reliance on school security project grants from the Commissioner available to fund the costs of compliance with Alyssa's Law.

The Authority's compliance process is based primarily on the school district's submission of a certification from a local law enforcement official with jurisdiction in the municipality where a school building is located, confirming that the school building is equipped with a panic alarm that, upon activation, transmits a signal or message to the local municipal police department, or in the case of a school building in a municipality without a local municipal police department, transmits a signal or message to a location designated by the Superintendent of State Police.

The rules provide that once a school district has demonstrated compliance with Alyssa's Law with respect to one or more school buildings in a district, the Authority will issue a notice of compliance determination to the school district. The Authority's compliance determination is a prerequisite for the school district to apply to the Commissioner for grant funding to reimburse the school district for the installation costs for existing systems and equipment that satisfy Alyssa's Law, or for the costs of planned installations to achieve compliance with Alyssa's Law. The Rules provide that the Authority will transmit the notice to the school district and the Department of Education to facilitate any grant application that the school district may make to access grant funding available through the Commissioner for the costs of installation of panic alarms or alternate emergency mechanisms in satisfaction of Alyssa's Law.

Requested Board Action

The Members of the Authority are requested to approve the filing of the Notice of Special Adoption and Concurrent Proposal to effect the immediate adoption of the attached rules entitled "Procedures for Compliance with Alyssa's Law"; as well as the proposal and publication of these rules for public comment and formal adoption in the normal course.

The specially adopted new rules shall be effective for a period not to exceed six months from the date of special adoption (insert date of special adoption).

Concurrently, the provisions of these new rules are being proposed for permanent adoption, subject to a 60-day public comment period and publication upon formal adoption, and effective for a full seven-year period, in accordance with the normal rulemaking requirements of the Administrative Procedure Act, N.J.S.A. 52:14B-1 et seq.

The agency special adoption and concurrent proposal follows:

Summary

On February 6, 2019, Governor Murphy signed P.L. 2019, c. 33, Alyssa's Law, requiring that each public elementary and secondary school building in the State be equipped with a panic alarm to alert law enforcement in the event of a school security emergency. Alyssa's Law provides that funding for compliance with the panic alarm requirement would be made available through the proceeds of general obligation bonds issued under the Securing Our Children's Future Bond Act, P.L. 2018 c. 119. Alyssa's Law further requires that the New Jersey Schools Development Authority (the "Authority") adopt regulations, to be effective immediately upon filing and for a period of six months, thereafter to be formally amended or adopted, to establish a program to effectuate the purposes of Alyssa's Law.

The New Jersey Schools Development Authority, in consultation with the Commissioner of the Department of Education, now adopts by special adoption and concurrently proposes new rules that specify the procedures for determining school districts' compliance with Alyssa's Law.

A section-by-section summary of the new rules follows.

Subchapter 1. General Provisions

§ 19:32A-1.1 Applicability and scope

This section sets forth the chapter's purpose and scope, which is to implement the provisions of Alyssa's Law, P.L. 2019, c. 33 (N.J.S.A. 18A:41-11) (hereinafter "Alyssa's Law" or "the Act"), which provides that all school facilities shall include a panic alarm connected to local law enforcement, and provides further that a portion of the proceeds of general obligation bonds issued pursuant to the Securing Our Children's Future Bond Act, P.L. 2018 c. 119 (the "Bond Act") shall be utilized to fund the cost of the panic alarms or other alternative mechanisms approved by the Department of Education (the "Department") required in school buildings under Alyssa's Law. The proposed rules provide the mechanism whereby school districts can demonstrate compliance with Alyssa's Law.

§ 19:32A-1.2 Construction of rules

This section provides that the rules shall be liberally construed to permit the Authority to discharge its statutory obligations under Alyssa's Law.

§ 19:32A-1.3 Definitions

This section defines terms used throughout the chapter.

The Authority proposes a definition for "alternate emergency mechanism" which means a device or system that generates a notification to local law enforcement in the event of a school security emergency, as approved by the Department. In conjunction with the Department's rules on security grant funding proposed at 6A:26-4.1 et seq., the proposed definition implements the provisions of N.J.S.A. 18A:41-11 allowing the Department to approve an alternative emergency mechanism to comply with Alyssa's Law, and achieves the goal of Alyssa's Law to equip each

school building with an emergency mechanism to notify local law enforcement in the event of a school security emergency.

The Authority proposes a definition for "Alyssa's Law" which means P.L. 2019, c. 33 (N.J.S.A. 18A:41-10 to -13).

The Authority proposes a definition for "compliance determination" which means a determination of the Authority that a school district has demonstrated compliance with Alyssa's Law with respect to one or more school buildings within the school district, which determination shall be memorialized in a formal, written Notice of Compliance Determination.

The Authority proposes a definition for "compliance plan" which means the document submitted to the Authority by a school district as part of the compliance determination review process that sets forth the school district's plan for achieving compliance with Alyssa's Law with respect to any non-compliant school buildings in the school district, including, if applicable, reference to the school district's application for school security project grant funding under N.J.A.C. 6A:26A-4.1 et seq. to comply with Alyssa's Law.

The Authority proposes a definition for "New Jersey Schools Development Authority" or "the Authority", or "SDA" which means the New Jersey Schools Development Authority established pursuant to N.J.S.A. 52:18A-237.

The Authority proposes a definition for "non-compliant school building" which means a school building that is not equipped with a panic alarm or alternative emergency mechanism satisfying the requirements of Alyssa's Law.

The Authority proposes a definition for "notice of compliance determination" which means the formal, written memorialization of the SDA's determination that a school district has demonstrated compliance with Alyssa's Law with respect to one or more school buildings within the school district.

The Authority proposes a definition for "panic alarm" which means a silent security system signal generated by the manual activation of a device to alert law enforcement to a life-threatening or emergency situation requiring a response from law enforcement, as set forth in N.J.S.A. 18A:41-11.

The Authority proposes a definition for "school" which means an educational institution that includes any of the grades kindergarten through twelve.

The Authority proposes a definition for "school building" which means a building owned or leased by a school district and used to permanently house students in any combination of grades kindergarten through twelve.

The Authority proposes a definition for "school district" or "district" which means a local or regional school district, a county special services school district, a county vocational school district, and a district under partial or full State intervention pursuant to P.L.1987, c.399 (C.18A:7A-34 et seq.), but which, for the purposes of this chapter, does not include charter or renaissance schools.

The Authority proposes a definition for "school security project grant" which means a grant of funds to a district for a school security project under N.J.A.C. 6A:26A-4.1 to -4.4, which shall include funding of installation of panic alarms in compliance with Alyssa's Law, N.J.S.A. 18A:41-11 et seq. if needed, and may include funding of security measures to implement the provisions of N.J.S.A. 18A:7G-5.2.

The Authority proposes a definition for "security project" which means the construction, improvement, alteration or modernization of all or any part of a school building in a school district for school security purposes, including the installation of panic alarms and silent security systems. A security project shall not include routine maintenance.

The Authority proposes a definition for "school security emergency" which means a lifethreatening or emergency situation requiring a response from law enforcement, including, but not limited to a non-fire evacuation, lockdown, or active shooter situation, which situation occurs in or near a school building.

Subchapter 2. Alyssa's Law Compliance and School Security Grant Procedures § 19:32A-2.1 Mandatory school district compliance with Alyssa's Law

This section specifies the mandatory nature of school district compliance with Alyssa's law. Subsection (a) provides that each school district in the State is required to demonstrate compliance with Alyssa's Law with respect to each school building in such school district, by submitting to the Authority an application for a compliance determination, identifying each school building in the school district and providing documentation sufficient to enable the Authority to evaluate and determine whether each school building is in compliance with Alyssa's Law. Subsection (b) emphasizes that compliance with Alyssa's Law is a prerequisite for eligibility for school security project grant funding under N.J.A.C. 6A:26A-4.1 et seq., specifying that when applying for a school security project grant, a school district must submit an application to the Authority for a compliance determination prior to, or simultaneous with, the school district's application to the Commissioner for a school security project grant under N.J.A.C. 6A:26A-4.1 et seq. Finally, subsection (c) indicates that Alyssa's Law compliance review is required even for school districts that opt not to seek available school security project funding, providing that school districts that do not elect to apply to the Commissioner for a school security project grant under N.J.A.C. 6A:26A-4.1 et seq. must apply to the Authority for a compliance determination no later than sixty days after the grant application deadline established

by the Commissioner for submission of applications for a school security project grant under N.J.A.C. 6A:26A-4.1 et seq.

§ 19:32A-2.2 Demonstrating school district compliance with Alyssa's Law

This section provides the standards for determining compliance with the Alyssa's Law. The section provides that in order to demonstrate compliance with the requirements of Alyssa's Law, a school district must submit to the Department for each school building a certification of a law enforcement official with jurisdiction in the municipality in which the school building is located, attesting that such school building is equipped with a silent panic alarm that, upon activation, transmits a signal or message to the local municipal police department, or a location designated by the Superintendent of State Police. Alternatively, a school district may demonstrate that a school building is equipped with an alternative emergency mechanism if such alternative emergency mechanism is approved by the Department.

This section further provides that if a school district cannot demonstrate compliance with the requirements of Alyssa's Law with respect to one or more of the school buildings located in the school district, then the school district must install a panic alarm or an approved alternative emergency mechanism in such non-compliant school building, and can apply to the Commissioner for a grant covering the costs of such proposed installation, pursuant to the procedures specified in these regulations and in the Department's regulations at N.J.A.C. 6A:26A-4.1 et seq.

§ 19:32A-2.3 School District application for Alyssa's Law compliance determination

(a) This section details the process for applying to the Authority for a compliance determination.

Subsection (a) provides that a school district shall apply for a compliance determination using a form

provided by the Authority. Subsection (b) provides that the Authority determination will be made based on the information supplied by the school district. Subsections (c) and (d) define the information to be supplied by the school district for this review, starting with the subsection (c) requirement of submission of a full list of all school buildings in the school district, which shall be accompanied by a certification of the Superintendent or Business Administrator for the school district, attesting to the completeness and accuracy of the list. Further, subection (d) specifies that for each school building on the list, the school district shall demonstrate whether the school building is equipped with a silent panic alarm system that satisfies Alyssa's Law, by supplying: a manufacturer's or other description of the panic alarm system, including a description of the method of operation of the panic alarm for signaling local law enforcement, sufficient to demonstrate how the proposed installation will satisfy the requirements of Alyssa's Law; photo or video evidence of the panic alarm installed in at least one location in the school building; and a certification by a law enforcement official with jurisdiction in the municipality in which the school building is located, confirming that the school building is equipped with a panic alarm that, upon activation, transmits a signal or message to the local municipal police department, or in the case of a school building in a municipality without a local municipal police department, transmits a signal or message to a location designated by the Superintendent of State Police. Subsection (e) requires the district to submit a compliance plan for any and all school buildings in the district that are not demonstrated to be in compliance with Alyssa's Law. The compliance plan shall describe how the school district intends to satisfy the requirements of Alyssa's Law in all non-compliant school buildings in the school district, and may include reference to the school district's planned or pending application for school security grant funding pursuant to N.J.A.C. 6A:26A-4.1 et seq. Finally, subsection (f) provides that the compliance plan shall be submitted by the school district either as part of the compliance determination application, or within thirty days of submission of the compliance determination application.

§ 19:32A-2.4 Determinations upon completion of compliance review

This section provides that SDA shall review the materials submitted by the school district and shall determine, for each school building listed by the school district, whether the school building is equipped with a silent panic alarm in compliance with Alyssa's Law. This section further provides that if the SDA determines that a school building is equipped with an alternate emergency system that, if approved by the Department, may satisfy the requirements of Alyssa's Law, SDA shall recommend that the Department approve the alternate emergency system, and if approval is granted by the Department, SDA shall determine the school building to be in compliance with Alyssa's Law. Finally, this section provides that SDA shall provide the school district with a notice of compliance for all school buildings demonstrated to be in compliance with Alyssa's Law, and shall transmit such notice of its determinations to the Commissioner to facilitate grant applications for school security project grants.

§ 19:32A-2.5 Grant funding available to facilitate Alyssa's Law compliance

This section specifies that in order for a school district to receive funding available for compliance with Alyssa's Law, a school district shall apply to the Commissioner of the Department (the "Commissioner") for a school security project grant, pursuant to regulations at N.J.A.C. 6A:26A-4.1 et seq. This section provides that the grant application must address all of the school buildings in the school district, and may request, for the various school buildings within the school district, either retroactive funding of a completed panic alarm installation, or prospective funding of a planned panic alarm installation to comply with Alyssa's Law. This

section further provides that a school security grant application may also request funding for a school security project involving security measures to implement the provisions of N.J.S.A. 18A:7G-5.2, but cautions that such grant funding will only be available if the school district has demonstrated compliance with Alyssa's Law.

§ 19:32A-2.6 Submission of certification upon completion of panic alarm or alternate emergency mechanism installations in compliance with Alyssa's Law

This section specifies the requirements for demonstrating compliance with Alyssa's Law for those installations of panic alarms or alternate emergency mechanisms occurring after a school district has received an initial notice of compliance determination. Subsection (a) of this section provides that upon completion of an installation of a panic alarm or alternate emergency mechanism in satisfaction of Alyssa's Law at any school building previously included in a compliance plan under N.J.A.C. 19:32A-2.3(e), the school district shall submit to the Authority, upon completion of the work or at such other time as may be specified in regulations at N.J.A.C. 6A:26A-4.1 et seq. or in any grant agreement relating to such work, a certification of a law enforcement official as described in N.J.A.C. 19:32A-2.3(d)3. Subsection (b) of this section requires that a school district shall supply any other documentation reasonably requested by the Authority to demonstrate a previously non-compliant school building's compliance with Alyssa's Law, in order to permit the Authority to update its compliance determination for the school district to include newly-compliant school buildings. Subsection (c) provides that the Authority shall provide an updated notice of compliance determination to the school district and to the Department, upon the school district's submission of documentation under this section, as additional panic alarm or alternate emergency mechanism installations are completed, if the

documentation submitted is sufficient to demonstrate a school building's compliance with Alyssa's Law.

As the Authority has provided a 60-day comment period for this notice of proposal, the notice is excepted from the rulemaking calendar requirements pursuant to N.J.A.C. 1:30-3.3(a)5.

Social Impact

The proposed new rules will allow the SDA to evaluate and determine school districts' compliance with Alyssa's Law, and issue a notice of compliance determination to school districts that demonstrate compliance with Alyssa's Law with respect to one or more school buildings in the school district. The Authority's issuance of the notice of compliance will facilitate the process for the Commissioner's issuance of school security grants for installation of panic alarms and alternate emergency mechanisms in compliance with Alyssa's Law, as well as other school security projects as required by N.J.S.A. 18A:7G-5.2, all of which has the positive social impact of making students and staff feel secure in the school environment, so that effective learning can take place.

Economic Impact

The proposed new rules will create a positive economic impact for businesses engaged in school construction and school security, as school districts will be required to demonstrate compliance with Alyssa's Law, and to the extent such school districts may be required to engage school construction and school security firms to install equipment or systems to comply with Alyssa's Law, this demand will create business for these industries.

Federal Standards Statement

The proposed new rules implement State statutes, namely Alyssa's Law, P.L. 2019 c.33 (N.J.S.A. 18A:41-10 et seq.) and the Securing Our Children's Future Bond Act, P.L. 2018 c. 119. There are no Federal standards or requirements governing the subject matter of these rules which apply only to New Jersey school districts that are required to demonstrate their compliance with Alyssa's Law. A Federal standards analysis, therefore, is not required.

Jobs Impact

The proposed new rules may result in the generation of jobs in the school construction and school security industries as a result of the requirement that school districts comply with Alyssa's Law, through school district engagements of school construction and school security firms to perform installation of panic alarms or alternate emergency mechanisms to satisfy Alyssa's Law.

Agriculture Industry Impact

The proposed new rules will have no impact on the agriculture industry as the requirement for installation of panic alarms or alternate emergency mechanisms in school buildings in fulfillment of Alyssa's Law will not require the acquisition of real property.

Regulatory Flexibility Statement

The proposed new rules do not impose recording, recordkeeping or other compliance requirements on small businesses as defined by N.J.S.A. 52:14B-16 et seq., the Regulatory Flexibility Act. The Rules proposed for adoption primarily impact New Jersey school districts, and impose recording, recordkeeping and compliance requirements on school districts that are required to submit documentation to demonstrate compliance with the requirements of Alyssa's Law.

Housing Affordability Impact Analysis

The proposed new rules will have no impact on the affordability of housing or on the average cost of housing in the State. The rules establish standards for the Authority's determination of a school district's compliance with the requirements of Alyssa's Law.

Smart Growth Development Impact Analysis

The proposed new rules will have an insignificant impact on smart growth development because it is extremely unlikely that the adoption of the rules would evoke a change in housing production in the State of New Jersey Planning Areas 1 or 2, or within designated centers under the State Development and Redevelopment Plan.

Racial and Ethnic Community Criminal Justice and Public Safety Impact

There is an extreme unlikelihood that the proposed new rules would have an impact on pretrial detention, sentencing, probation, or parole policies concerning juveniles and adults in the State because the rules establish standards for determining school districts' compliance with the requirements of Alyssa's Law.

Full text of the special adoption and concurrent proposal follows.

Subchapter 1. General Provisions

§ 19:32A-1.1 Applicability and scope

These rules are promulgated by the New Jersey Schools Development Authority ("SDA" or the "Authority") to effectuate the purposes of Alyssa's Law, P.L. 2019, c. 33

(N.J.S.A. 18A:41-11) (hereinafter "Alyssa's Law" or "the Act"), in conjunction with complementary rules simultaneously proposed by the Commissioner (the "Commissioner") of the Department of Education (the "Department") as N.J.A.C. 6A:26A-4.1 et seq. to effectuate the Securing Our Children's Future Bond Act, P.L. 2018, c. 119 (hereinafter, the "Bond Act"). Alyssa's Law provides that all school facilities shall include a panic alarm connected to local law enforcement, and provides further that a portion of the proceeds of general obligation bonds issued under the Bond Act shall be utilized to fund the cost of the panic alarms required in school buildings under Alyssa's Law, or other alternative mechanisms approved by the Department under that Act. These rules are adopted in order to provide the mechanism whereby school districts can demonstrate compliance with Alyssa's Law.

§ 19:32A-1.2 Construction of rules

This chapter shall be liberally construed to permit the Authority to discharge its statutory obligations under Alyssa's Law.

§ 19:32A-1.3 Definitions

(a) The following words and terms, when used in this subchapter, shall have the following meanings unless the context clearly indicates otherwise. Words in the singular shall include the plural and words in the plural shall include the singular where the context so requires.

"Alternate emergency mechanism" means a device or system that generates a notification to local law enforcement in the event of a school security emergency, as approved by the Department.

"Alyssa's law" or "the Act" means P.L. 2019, c. 33 (N.J.S.A. 18A:41-10 to -13).

"Compliance determination" means a determination of the Authority that a school district has demonstrated compliance with Alyssa's Law with respect to one or more school buildings within the school district, which determination shall be memorialized in a formal, written Notice of Compliance Determination.

"Compliance plan" means the document submitted to the Authority by a school district as part of the compliance determination review process that sets forth the school district's plan for achieving compliance with Alyssa's Law with respect to any non-compliant school buildings in the school district, including, if applicable, reference to the school district's application for school security project grant funding under N.J.A.C. 6A:26A-4.1 et seq. to comply with Alyssa's Law.

"New Jersey Schools Development Authority" or "the Authority" or "SDA" means the New Jersey Schools Development Authority established pursuant to N.J.S.A. 52:18A-237.

"Non-compliant school building" means a school building that is not equipped with a panic alarm or alternative emergency mechanism satisfying the requirements of Alyssa's Law.

"Notice of compliance determination" means the formal, written memorialization of the SDA's determination that a school district has demonstrated compliance with Alyssa's Law with respect to one or more school buildings within the school district.

"Panic alarm" means a silent security system signal generated by the manual activation of a device to alert law enforcement to a life-threatening or emergency situation requiring a response from law enforcement, as set forth in N.J.S.A. 18A:41-11.

"School" means an educational institution that includes any of the grades kindergarten through twelve.

"School building" means a building owned or leased by a school district and used to permanently house students in any combination of grades kindergarten through twelve.

"School district" means a local or regional school district, a county special services school district, a county vocational school district, and a district under partial or full State intervention pursuant to P.L.1987, c.399 (C.18A:7A-34 et seq.). For the purposes of this chapter, school district does not include charter or renaissance schools.

"School security project grant" means a grant of funds to a school district for a school security project under N.J.A.C. 6A:26A-4.1 to -4.4, which shall include funding of installation of alarms in compliance with Alyssa's Law, N.J.S.A. 18A:41-11 et seq. if needed, and may include funding of security measures to implement the provisions of N.J.S.A. 18A:7G-5.2.

- Subchapter 2. Alyssa's Law Compliance and School Security Grants to Facilitate

 Compliance with Alyssa's Law
- § 19:32A-2.1 Mandatory school district compliance with Alyssa's Law
- (a) Each school district in the State is required to demonstrate compliance with Alyssa's Law with respect to each school building in such school district, by submitting to the Authority an application for a compliance determination, identifying each school building in the school district and providing documentation sufficient to enable the Authority to evaluate and determine whether each school building is in compliance with Alyssa's Law.
- (b) In order to be eligible to receive a school security project grant under N.J.A.C. 6A:26A-4.1 et seq., a school district must submit an application to the Authority for a compliance determination prior to, or simultaneous with, the school district's application to the Commissioner for a school security project grant under N.J.A.C. 6A:26A-4.1 et seq.
- (c) School districts that do not elect to apply to the Commissioner for a school security project grant under N.J.A.C. 6A:26A-4.1 et seq. must apply to the Authority for a compliance determination no later than sixty days after the grant application deadline established by the Commissioner for submission of applications for a school security project grant under N.J.A.C. 6A:26A-4.1 et seq.
- § 19:32A-2.2 Demonstrating school district compliance with Alyssa's Law
- (a) In order for a school district to demonstrate compliance with the requirements of Alyssa's Law, it must submit to the Authority proof that each school building in the district is equipped with a silent panic alarm that, upon activation, transmits a signal or message to the local municipal police department, or in the case of a school facility in a municipality without a local municipal police department, transmits a signal or message to a location

designated by the Superintendent of State Police. Such proof shall be provided for each school building in the school district, in the form of a certification of a law enforcement official with jurisdiction in the municipality in which the school building is located.

- (b) Alternatively, a district may demonstrate that a school building is compliant with Alyssa's Law if such school building is equipped with an alternative emergency mechanism that is approved by the Department.
- (c) If a school district cannot demonstrate compliance with the requirements of Alyssa's Law with respect to one or more of the school buildings located in the school district, then the school district must install a panic alarm or an approved alternative emergency mechanism in such non-compliant school building, and can apply to the Commissioner for a grant covering the costs of such proposed installation, pursuant to the procedures specified in the Commissioner's regulations at N.J.A.C. 6A:26A-4.1 et seq.
- § 19:32A-2.3 School District application for Alyssa's Law compliance determination
- (a) A school district shall apply to the Authority for a compliance determination utilizing the application form supplied by the Authority.
- (b) The Authority shall review and evaluate the district's compliance with Alyssa's Law based on information supplied by the school district as part of the school district's application to the Authority.
- (c) The school district shall provide, as part of the application, a full list of all school buildings in the school district. The list shall be accompanied by a certification of the Superintendent or Business Administrator for the school district, attesting to the completeness and accuracy of the list.

- (d) For each school building on the school district's list, the school district shall demonstrate whether the school building is equipped with a panic alarm system that satisfies Alyssa's Law, in accordance with section 2.2 above, by supplying the following:
 - 1. the manufacturer's description of the panic alarm system, or a brief description of the panic alarm system or equipment to be installed, including a description of the method of operation of the panic alarm for signaling local law enforcement, sufficient to demonstrate how the proposed installation will satisfy the requirements of Alyssa's Law;
 - 2. photo or video evidence of the panic alarm installed in at least one location in the school building; and
 - 3. a certification, in the form provided by the Authority, by a law enforcement official with jurisdiction in the municipality in which the school building is located, confirming that the school building is equipped with a panic alarm that, upon activation, transmits a signal or message to the local municipal police department, or in the case of a school building in a municipality without a local municipal police department, transmits a signal or message to a location designated by the Superintendent of State Police.
- (e) If, for any school building on the school district list, the school district cannot demonstrate that the school building is equipped with a panic alarm or alternate emergency mechanism in compliance with Alyssa's Law, the school district shall provide a compliance plan indicating how the school district will satisfy the requirements of Alyssa's Law in all non-compliant school buildings in the school district, including, if applicable, reference to the school district's planned or pending application for school security grant funding pursuant to N.J.A.C. 6A:26A-4.1 et seq.

(f) The school district shall supply the compliance plan to the Authority with the compliance determination application, or within thirty days of submission of the compliance determination application.

§ 19:32A-2.4 Determinations upon completion of compliance review

- (a) SDA shall review the materials submitted by the school district and shall determine, for each school building listed by the school district, whether the school building is equipped with a panic alarm in compliance with Alyssa's Law.
- (b) Alternatively, if upon review of the materials submitted by the school district, the SDA determines that a school building is equipped with a system or equipment that may constitute an alternate emergency system if approved by the Department, and if approved, would satisfy the requirements of Alyssa's Law, SDA shall;
 - recommend that the Department approve the alternate emergency system,
 and
 - 2. if approval is granted by the Department, SDA shall determine the school building to be in compliance with Alyssa's Law.
- (c) SDA shall provide the school district with a notice of compliance determination for all school buildings demonstrated to be in compliance with Alyssa's Law, and shall transmit such notice of its determinations to the school district and the Commissioner to facilitate grant applications for school security project grants.

§ 19:32A-2.5 Grant funding available to facilitate Alyssa's Law compliance

In order to receive school security project grant funding available for compliance with Alyssa's Law, a school district shall apply to the Commissioner for a school security project grant, pursuant to regulations at N.J.A.C. 6A:26A-4.1 et seq.

- § 19:32A-2.6 Submission of certification upon completion of panic alarm or alternate emergency mechanism installations in compliance with Alyssa's Law
- (a) When a school district completes an installation of a panic alarm or alternate emergency mechanism in satisfaction of Alyssa's Law at any school building previously included in a compliance plan under N.J.A.C. 19:32A-2.3(e), the school district shall submit to the Authority, upon completion of the work or at such other time as may be specified in regulations at N.J.A.C. 6A:26A-4.1 et seq. or in any grant agreement relating to such work, a certification of a law enforcement official as described in N.J.A.C. 19:32A-2.3(d)3.
- (b) The school district shall submit any other documentation reasonably requested by the Authority to demonstrate a previously non-compliant school building's compliance with Alyssa's Law, in order to permit the Authority to update its compliance determination for the school district to include newly-compliant school buildings
- (c) The Authority shall provide an updated notice of compliance determination to the school district and to the Department, upon the school district's submission of documentation under this section, as additional panic alarm or alternate emergency mechanism installations are completed, if the documentation submitted is sufficient to demonstrate a school building's compliance with Alyssa's Law.

Subchapter 3. Appeals

§ 19:32A-3.1 Appeals

- (a) School districts may appeal from decisions or determinations of the Authority under these rules, and such appeals may be requested in writing, and an opportunity given for any informal hearing on the papers, in person or via telephone with Authority staff.

 Such written request for an informal hearing must be made within 30 days of the receipt of the Authority's decision.
- (b) In the event of an adverse decision after an informal hearing under (a) above, or if a school district determines not to seek an informal hearing, and providing further, that the dispute or controversy is a contested case, as defined in N.J.S.A. 52:14B-2(b), a district may request, within 45 days of the written decision resulting from the informal hearing or the determination of the Authority if an informal hearing is not sought, a formal hearing.
- (c) Upon filing of the initial pleading in a contested case, the Board of the Authority may by resolution either retain the matter for hearing directly or transmit the matter for hearing before the Office of Administrative Law. Such hearings shall be governed by the provisions of the Administrative Procedure Act, N.J.S.A. 52:14B-1 et seq. and 52:14F-1 et seq., and the Uniform Administrative Procedure Rules, N.J.A.C. 1:1.
- (d) Every determination of a dispute or controversy arising from this chapter by the Authority, constituting final agency action by the Board, shall be embodied in a written decision which shall set forth findings of fact and conclusions of law pursuant to the applicable rules of the Office of Administrative Law.

Resolution-7f.

Extension of Existing Regulations: Notice of Re-adoption (without Amendments) -- Procedures for Compliance with Alyssa's Law

Resolution

WHEREAS, P.L. 2007, 137 (N.J.S.A. 52:18A-238(k)) requires that the Members of the New Jersey Schools Development Authority (SDA or the Authority) adopt, amend and repeal rules and regulations to carry out the provisions of P.L. 2000, c. 72 (C. 18A:7G-13e) and P.L. 2007, c. 137 (C. 52:18A-238k) and

WHEREAS, on February 6, 2019, "Alyssa's Law" (P.L. 2019, c. 33) was enacted, requiring that each public elementary and secondary school building in the state be equipped with a panic alarm to alert law enforcement in the event of a school security emergency; and

WHEREAS, Alyssa's Law provided that funding for compliance with the panic alarm requirement would be made available through the proceeds of bonds issued under the Securing Our Children's Future Bond Act, P.L. 2018 c. 119; and

WHEREAS, Alyssa's Law further required that the SDA adopt regulations, to be effective immediately upon filing and for a period of six months, thereafter to be formally amended or adopted, in order to establish a program to effectuate the purposes of Alyssa's Law; and

WHEREAS, SDA, in conjunction with the Commissioner of the Department of Education (DOE) has developed rules (the Rules) for implementing a program to allow SDA to assess school districts' compliance with the requirements of Alyssa's Law with respect to each school building in each district; and

WHEREAS, SDA management is seeking Board authorization and approval to proceed with the filing of a Notice of Special Adoption and Concurrent Proposal of the Rules, captioned "Procedures for Compliance with Alyssa's Law."; and

WHEREAS, upon the filing of the Notice of Special Adoption and Concurrent Proposal with the Office of Administrative Law, Rules Division, the Rules will be immediately adopted with no public comment period, for a period of six months; and

WHEREAS, the Rules simultaneously will be proposed for publication and public comment to facilitate their adoption in the normal course, effective for a standard seven-year expiration period upon final adoption.

WHEREAS, SDA management recommends that the Members of the Authority authorize and approve the adoption of the Rules as proposed consistent with the memorandum presented to the Board on this date and incorporated herein.

NOW, THEREFORE, BE IT RESOLVED, that the Members of the Authority hereby authorize and approve the filing of the Notice of Special Adoption and Concurrent Proposal to effectuate the immediate adoption of the attached Rules entitled "Procedures for Compliance with Alyssa's Law".

BE IT FURTHER RESOLVED, that the Members of the Authority authorize and approve the proposal and publication of these rules for public comment and formal adoption in the normal course.

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately, but no action authorized herein shall have force and effect until 10 days, Saturdays, Sundays and public holidays excepted, after a copy of the minutes of the Authority meeting at which this resolution was adopted has been delivered to the Governor for his approval, unless during such 10 day period, the Governor shall approve same, in which case such action shall become effective upon such approval.

The Risk Management staff continues to participate at mandatory pre-bid and pre-construction meetings to instruct and inform bidders regarding SDA's SBE goals, policies and procedures, including:

- Small Business Enterprise subcontracting goal of 25% of all contracts
- County workforce goals for minorities and females
- Detailed process procedures to monitor and track the progress made toward these goals throughout the life cycle of each project

At these meetings, vendors are strongly encouraged to identify and hire minority-owned and womenowned firms, as well as locally-based enterprises, for diverse business participation on all school building projects. Additional outreach strategies are discussed and utilized.

SMALL BUSINESS ENTERPRISE (SBE) COMPLIANCE MONITORING

The SDA regularly exceeds the State-mandated 25% SBE goal. The total SDA contract dollars awarded through August 31, 2019 was \$27,396,827. The figures below demonstrate compliance with this requirement.

SBE Breakdown

The total contract dollars awarded to all SBE contractors was \$8,251,148 (including minorities, women and veterans). This represents 30.12% of all SDA contracts.

SUBJECT: Monthly Financial Report – September 2019

The Office of the Chief Financial Officer is providing the attached monthly financial report to the Members of the Authority for their information. Included on pages 1 and 2 of this report is a "Financial Summary" of the Authority's activities for the year. On pages 3, 3-1 and 4 of the report is a summary of the Authority's operating and capital expenditures. Page 5 contains a breakdown of the Authority's headcount information by department. The basic financial statements follow on pages 6 and 7.

Fund Reporting Operating Expenses (Year-to-Date Actual vs. Budget)

For September 2019 year to date, Authority operating expenses, \$13.0 million, are \$2.0M lower than budget for the *corresponding period*. The variance is primarily related to lower year to date personnel costs, \$1.2 million, which includes a \$1.0M decrease in payroll and benefits costs as a result of having 49 fewer FTEs than budgeted. Additionally, lower than anticipated spending related to facilities & general office expenses \$221K and information systems \$251K contributed to the variance.

Fund Reporting Operating Expenses (Year-to-Date Actual vs. Prior Year Actual)

For September 2019 year to date, Authority operating expenses, \$13.0 million, are \$843K higher when compared to the *corresponding prior year*. This variance is mainly attributable to an increase in personnel costs, \$785K, primarily due to the 2018 Authority restructuring. The Authority is projecting that this increase will gradually dissipate over the remaining months of the year due to the staff reductions in July 2019.

School Facilities Project Expenditures (Year-to-Date Actual vs. Forecast)

For September 2019 year to date, project expenditures, \$228.0 million, are \$16.8 million lower than the capital spending forecast for the *corresponding period*. This variance is primarily a result of lower than forecasted expenditures for grant activity \$30M, design services (net of cost recovery settlement) \$4.5M, property acquisitions \$1.6M, lower-than-projected payroll expense allocations \$1.3M, and other project related cost \$3.2M. These reductions are partially offset by an increase in construction activity \$19.4M, as well as school furniture, fixtures & equipment related spending \$3.6M.

School Facilities Project Expenditures (Year-to-Date Actual vs. Prior Year Actual)

For September 2019 year to date, project expenditures, **\$228.0 million**, are lower by **\$8.3 million** when compared to the *corresponding prior year*. The variance is attributable to decreases in grant activity **\$34.2M**, project insurance costs **\$4.0M**, design services (net of cost recovery settlement) **\$4.6M**, and other project related costs **\$3.0M**. These decreases are partially offset by an increases in construction activity **\$30.7M**, and school furniture purchases **\$7.4M**.

Other

Since program inception, 85% of the funds authorized for the SDA Districts have been disbursed. Additionally, since program inception, 96% of all SDA disbursements relate to school facility projects and 4% relate to operating expense.

The *estimated value* of active school facilities, capital, emergent and ROD grant projects is approximately \$2B.

- ▶ Capital Assets total \$843,650 (net of accumulated depreciation of \$6,666,431), consisting of leasehold improvements (SDA offices), and capitalized software, equipment, furniture and fixtures in support of SDA operations. Depreciation on capital assets is generally calculated using the straight-line method over the life of each asset. For the year to date, Capital Expenditures are \$343,924 and Depreciation Expense is \$135,256.
- ▶ **Accrued Liabilities** total \$105.1 million, as follows:
 - Accrued project costs of \$24.6 million consisting of unpaid invoices (\$6.5 million) and retainage (\$18.1 million).
 - Accrued net pension liability of \$49.8 million.

 - Pollution remediation obligations (PRO) under GASB 49 net to \$3 thousand (PRO liability \$2.946 million, offset by expected cost recoveries of \$2.943 million).
