Dear Mr. DiNatale:

The New Jersey Schools Development Authority ("NJSDA") is in receipt of your October 24, 2018 protest letter on behalf of Site Enterprises, Inc. ("Site") relating to the above-referenced procurement for abatement and selective demolition services for the Cleveland Street Elementary School project in Orange, New Jersey (the "Procurement"). Site's protest letter challenges an award to the "low bidder" (i.e. Bismark Construction Corp. ("Bismark")). This letter is the NJSDA's formal response and final agency decision on Site's bid protest.

Site's letter, which was submitted the day after bids were received by the NJSDA, states that it "feel[s] that the low bidder did not have the proper paperwork in correspondence with the bid requirements." Furthermore, Site contends that the presumptive winning bidder was "missing Subs, necessary paperwork, as well as required DPMC Classifications." However, Site's letter further requests the opportunity to review the bids submitted by the lowest bidders "to ensure that the proper paperwork was included in the Bid Proposal."

On the same date that it submitted the instant Bid Protest, Site also submitted a request for copies of the bids received by the NJSDA for the above-referenced Procurement, pursuant to the New Jersey Open Public Records Act ("OPRA"). While any documents responsive to Site's OPRA request will be made available to Site consistent with the requirements of OPRA, it is plainly evident that the contentions set forth in Site's bid protest were made without having had the benefit of reviewing the other bids. Thus, Site's contentions are purely speculative and were made without any factual basis at the time of Site's bid protest submission. Speculative and factually unsupported bid protests are subject to summary rejection.

The foregoing notwithstanding, please be advised that the NJSDA has already rejected Bismark's bid as non-responsive. As such, your firm's protest is rejected as moot.
